Yesterday, Women United opened its campaign to create as much national disunity as possible. It had a secret conference in Room 807, 545 Fifth Ave., "to oppose; conscription of women for Army service."

Admission was by letter only, a letter which described the women's conscription bill as immoral and a blow to the country's morale.

Sent to Friends

The letter was sent to "friends," the usual list of pro-Fascists, Roosevelt-haters, and anti-Semites. Of the letter's seven paragraphs, two concern the conscription bill, five "the menace of Communism," the latest Axis line bugaboo.

"That Communism is a real menace to our war effort is shown by the writings of Washington correspondents and others in our daily press," the letter states over Mrs. Brown's signature.

This statement is identical in theme with the current Nazi campaign of psychological warfare the Axis is waging against the U. S. A.

Before Pearl Harbor, Women United was against every item of the President's foreign policy, including:

¶Aid to Britain, Russia and China. The Selective Service Act.

Repeal of the Neutrality Act. They worked with pro-Fascists:

¶George E. Deatherage, nightshirt Fascist head of the Knights of the White Camellia, who was kicked out of a job on a Navy project.

Robert M. Harriss, Father Coughlin's financial representative in the East.

The convicted Nazi agent, Laura Ingalls, No. 2 isolationist aviator. ¶Ida M. Cooper, New York representative of Elizabeth Dilling, the Chicago Red-baiter.

Curious Statement

Curiously, Women United now state: "We are heartily back of our Government taking every precaution against Nazi and Fascist sympathizers - as shown by their elimination of Deatherage of the White Camellias . . ."

It was Deatherage who wrote to Women United on Apr. 14, 1941, suggesting: "Your literature does not need to state the word Jew. All you have to do in order to place the blame where the people can understand it is to accuse the international banker."
