

FBI Given Complaints Against 'Mother's' Bloc

Mrs. Mynnie Fisher of Milwaukee, Wis., was ejected from the Capitol yesterday after shouting "Down with the British flag!" (according to her side of the story).

Capitol police said she and other members of her group had created a disturbance near a Senate reception room.

COMPLAINTS TO FBI

"Mothers' Mobilization Against H. R. 1776" (the lend-lease bill) is what this group calls itself, according to information from its own headquarters at the Plaza Hotel.

Complaints, it was learned today, have been made to the FBI against its sponsorship, as pro-Nazi, un-American and anti-Semitic.

A weekly pamphlet published by Charles B. Hudson in Omaha, Neb., (subscription \$5 a year) was quoted to the FBI in the complaint as having sponsored the demonstration.

PUBLICATION'S VIEW

In this publication of Feb. 3, 1941, (a copy was seen by a Daily News reporter) is this statement:

"Under our Constitution it is the right and duty of Americans to alter or abolish the present non-Christian, un-American, unconstitutional and socialistic Government at Washington, and institute a new government . . . holding those guilty of treason from the President down . . ."

"Hence if Congress does not kill the lend-lease bill and impeach F. D. R., the marchers on Washington can hold a constitutional convention as delegates from each state and dissolve the present unconstitutional usurpers, regardless of how they got in power. . ."

OPPOSED F. D. R. ELECTION

Mr. Hudson's publication first promoted a "March on Washington to Impeach President Roosevelt" before last fall's presidential election. However, in the Feb. 3 issue Mr. Hudson wrote:

"The March on Washington . . . to achieve permanent benefits must demand F. D. R.'s impeachment. . . This may be a bit dangerous now (but a lot more later if not done now)."

The same source of information reveals that in a circular published by Hudson he stated:

"Now visualize what aroused women can do to a Congress that, being men, is not afraid of men. A man fears nothing like he does a militantly aroused female. Cash in on that fact. The National Guard and Army could be used against a 'Male March on Congress.' The controlled press and radio could claim that such men were 'rebels,' 'Bolsheviks,' etc., regardless of the truth, but a 'Mothers' March on Washington' would tie all hands."

All hands, it seems from yesterday's incident, except those of Capitol police.

INFORMATION REFUSED

Note: The News called Plaza Hotel headquarters of the Mothers' Mobilization, was told Mrs. Fisher had been thrown out of the Capitol after she had shouted "Down with the British flag." The reporter asked information as to organization of the marchers, but was given none.
