



DURESS AND PERSUASION

B'nai B'rith Brags of its Endeavors to Gag Free Speech concerning Jews



ONTAINED in this booklet is a purported authentic record of what the Jewish anti-defamation societies and leagues—under the sponsorship of B'nai B'rith—are both attempting and achieving in

the way of cracking down on Gentile criticism of Jews, hostile attitudes toward Jews, or free speech of Christian Gentile publicists in discussion of the Jewish Question.

It becomes increasingly plain, from examining reports of Jewish activities in this regard, that Jews propose to put themselves above all public criticism or discussion, and whosoever dares call attention to any form of Jewish activity that

seems inimical to Gentile-Christian welfare is judged guilty of studied "insults" to the Jewish people as a whole.

Coupled with this condemnation is the weird psychology that whosoever approves of, or espouses, any of the accomplishments of Adolf Hitler or Nazi Germany, is likewise guilty of some sort of felony.

It is high time that Gentile Christians were made aware of what the Jewish societies, fraternities, and leagues are doing, month by month or year by year, to bring pressure to bear on any aspect of a Free Press or Free Speech that concerns the topic of Jewry.

Everything said about the Jew, or against the Jew, is "defamation."

"Defamation" has become a sort of megalomania with Jews. The Irish, the Swedes, the French, the Italians, ensconced as racials in America, do not thus rise up and fulminate every time their people are mentioned. The reason would seem to be that the Irish, the Swedes, the French, or the Italians are not aspiring to any subjugation of all other racials and are not especially jittery that their works may find them out. But the Jew, harnessed to an admitted plan to overcome all racial competitions, has to work overtime to

meet and lay the caustic criticism or open opposition directed at his head. "It's the hit cur that yelps!"

RECENTLY, B'nai B'rith brought out and circulated privately a highly interesting list of its achievements in one year in sweeping back the tidal wave of anti-Semitism with a whisk-broom. Its publicity-sheet was labeled—

On an inside cover, and under the caption "This Document is Confidential," the following blurb was noted—

For nearly a quarter century B'nai B'rith's Anti-Defamation League has fought all efforts to slander the Jewish name on stage and screen, radio and forum, in books and periodicals. Some estimate of its success may be made by comparing the situation today with that of a decade ago. Who does not remember the vulgar "Jewish comedians" of vaudeville, the grotesque cartoons that slandered Jews, the ridicule poked constantly at our people in periodicals of all kinds, and in movies? Today these insults appear hardly anywhere, largely because of the pioneer work of the League.

With the rise of Hitler to power in Germany, scores of his imitators sprang up in our own beloved country. Their subversive anti-Semitic efforts caused the League to redouble its work and expand its scope. Today it is dealing with hundreds of cases, some relatively trivial, many profoundly serious, but all requiring the kind of tactful, incisive handling that the League has perspected through its long experience and its widespread machinery.

Herewith we present a few cases handled by the League recently. We urgently request that this It contains nothing but a proud record of achievement in defense of the Jewish people, but its circulation among non-Jews might result in considerable misunderstanding as to the extent of hand, will read it avidly, thrilled to learn that works 52 weeks every year in their defense—the B'nai B'rith Anti-Defamation League.

WELL, suppose we cast an eye over the activities of this Anti-Defamation League and apprise ourselves how it professes to operate, to squelch individual attempts to call attention to Jewish machinations. Perhaps Gentile activities with which you are associated, have met with mysterious duress or pressure to thwart or suppress them, and this report of "accomplishments" will cast light upon the enigma.

Study the following paragraph-reports carefully. Take them individually and realize the significance—and eccentric psychology—operating behind each one. Note the numbers of times where the League brags openly of having suppressed certain books upon the subject of Jewry or Jewish racials, or how anti-Semitic publicists were "visited" and "persuaded" to alter their tactics. Is this sort of thing American, and Constitutional, or is it not?

Furthermore, what means were taken to "per-suade" these publicists to alter their tactics?

Books Squelched

Very careful consideration was given to the English version of Hitler's book "Mein Kampf." The danger of similar works flooding the country, in the event of "Mein Kampf's" financial success, influenced a decision to make every ethical effort to minimize the sale of the book. Our representatives were instructed on procedure. Pre-publication estimates of prospective sales approximated half a million. Latest advices indicate sales of approximately 6,000, marking a financial failure of the venture. It is reported that contemplated publication of other books of similar character has been abandoned.

Upon advice of the publication by Scribner & Son of Madison Grant's book "Conquest of a Continent," the Council decided to caution the Jewish pulpit and the Jewish press against the type of criticism calculated to advertise the book. Numerous responses of commendation and ready co-operation were received.

Complaint received in re the book, "T . . . " Investigation revealed the book now out of print with no possibility of further editions.

Liberation Defamed

Similarly gratifying response was had to the request from our office that librarians be forewarned of the nature of the Liberation Magazine, free copies of which were being offered to Libraries throughout the country.

C. The League became aware of efforts to place the anti-Semitic periodicals in the libraries of the country. This was being attempted through free distribution of those vicious un-American journals. Circulars have been mailed advising of this purpose and suggesting the tactful procedure by which libraries may be advised of the nature and purpose of such anti-Semitic organs.

The League was requested to stimulate interest in the nation-wide broadcast of an address by James G. MacDonald, High Commissioner selected by the League of Nations to head the International Commission for the relief of Refugees from Germany. Immediate attention was given, resulting in returns from over 100 communities, indicating how effectively they had aroused their communities' interest in the address.

Our attention was called to the potential dangers of weekly Newsreels, presenting with ill-advised supporting dialogue pictures of Modern Germany. The subject matter was taken up with the Hays organization and also with heads of theatrical chains. Assurance was given that every effort would be made to exert the utmost discrimination in the compilation of material for such films.

Editorials have been stimulated in many newspapers throughout the country. One from Oklahoma especially meritorious was reprinted by authorization of the newspaper. These reprints were circulated to our keymen. As a result, further editorials of friendly character have been noted in other papers, making definite references to the commendable American attitude conveyed in the Oklahoma item.

No Sympathy for Germany

Correspondence in re Pro-Nazi propaganda issued to subscribers to German-Medical Journals. This propaganda purporting to issue from the Deutsches Fichte-Bund of Hamburg. Additional information was secured demonstrating this organization to be a central propaganda office for Nazi material.

Correspondence with reference to reported efforts to create Nazi sympathy in America. A League investigation was set on foot at several points throughout the country with almost unanimous report that no such effort was noted.

Complaint against Congressman — for reported sympathy with the Hitler program against the Jews. Congressman — was interviewed and absolutely disavowed the statements charged against him. He charged political rivals with seeking to injure him.

American Legion "Written"

Correspondence with Mr. Lewis Johnson, National Commander of the American Legion, with reference to the Americanism Manual of the Legion. This quoted from Hamilton Fish's report to the American Congress on the subject of Communism. Mr. Johnson directed our attention to the fact that this reference was taken bodily from the Congressional Record, but agreed that it might be better to have been omitted, and gave assurance that the policy of the Legion was one of good will and better understanding; that the most rigid supervision would be invoked to obviate any similar future occurrence.

Several requests from women's organizations, asking the League counsel with regard to the issuance of chain letters and petitions to Washington officials in connection with the Nazi situation. Counsel of the League advised against such efforts and was appreciatively received and complied with.

A. The issuance of a most offensive New Year card was called to the attention of the League. Sender was communicated with. Expressed deep regret and intention not to offend similarly in the future.

B. Correspondence in connection with reported discrimination of the Dictaphone Company. New York representatives contacted, investigation made, and conclusion reached that report was unfounded.

Hitler Lecturer "Counteracted"

Correspondence with Louisville representatives in connection with pro-Hitler lecturer, copy of whose address was received. Technique for handling the situation was submitted, and in view of the fact that the lecturer had been booked for series of engagements, contacts were made to counteract properly the effect of such addresses.

Pursuant to requests made by Everett R. Clinchy, Secretary of National Conference Between Jews and Christians, cooperation was extended to further the good-will tour in which there participated a Catholic priest, a Protestant minister and a Rabbi.

A. League material furnished for contemplated book by Dr. Abraham Cronbach, the Hebrew Union College, on subject of discrimination against Jewish people.

B. Contact made with the mayor of important eastern city whose expression on the Nazi situation had aroused considerable criticism. Satisfactory explanation was made, demonstrating that the most highly criticized expressions were in fact distortions of newspaper reports.

C. Representative in Montreal requested information on Dr. —, Nazi propagandist scheduled for address at out-

standing Montreal clubs. Information furnished by the League. Speaking engagements subsequently cancelled. Correspondence with magazine, C-, in re offensive remarks by one of its columnists resulted in editorial explanation and assurance for columnar supervision in the tuture.

I. Copies of leastlets distributed in a western city charging Ritual Murder against the Jews. These leaflets having emanated from England, the subject has been taken up with our English brethren to ascertain whether or not anything can be done from that end. Insofar as the local phase is concerned, the Anti-Defamation representative has taken the matter in charge.

Hotels Must Take Jews

Commissioner Judge A. K. Cohen reported his successful consummation of several matters connected with Hotel discriminations in New England.

Correspondence with American Automobile Association in re Birsch Point Inn of Minnesota, Johnson's Rustic Tavern of Michigan, both official A. A. A. Hotels, discriminating against Jews in their advertising. The League was furnished with copies of new advertising folders, omitting all discriminatory references. The Secretary interviewed the Executive Director of the American Automobile Association of Washington, upon the occasion of a succeeding visit, and entered into very friendly relations, assuring the maximum co-operation of this influential association with the purposes of the League.

- B. Several complaints were received with reference to the writings of one Olga (Negress), whose articles had displayed an amazing venom against the Jews. Investigation and report are still pending.
- C. Complaint against a national credit rating agency for unnecessarily stating in an analytical report that all officers of a certain firm were Hebrews. The correspondence revealed a prejudiced editor, an assurance of more careful supervision was given.

Mother Goose Taboo

Further investigation of Mother Goose rhymes. Survey of libraries and book stores revealed the McLaughlin edition as still objectionable. Promise received to make proper changes in forthcoming editions.

A. From several sources came complaints against the Walt Disney Silly Symphonies picture, "Three Little Pigs." While the League recognized the seeming triviality of the incident, it none-the-less initiated through the Los Angeles Committee effort to insure against repetitions of this sort of matter.

A. Correspondence received from Mr. —, of a newspaper syndicate. Mr. — presented his idea and plan for publicity on — (anti-Semitic organization). On suggestion of the Council, Mr. — was dissuaded from proceeding with his plan and agreed with reasoning of the Council.

- H. Similar protest was lodged against Rev. of Minnesota. Investigations revealed that the slanderous remarks were being omitted from current broadcasts.
- F. Reported anti-Jewish boycott signs displayed publicly in town of —— came to our attention. Further information was secured, but the League had been advised that through the local committee, solution of the problem had been effected and the signs removed.

Cases of pro-Hitler activities of two Wisconsin University Professors were investigated. There appeared insufficient evidence of any definite association or expression.

Chain Store Disciplined

- E. Numerous complaints against a prominent chain candy store organization charging discrimination against Jews in employment were received. Efforts to trace down actual evidence have thus far failed.
- A. Complaint against the director of C— Chain Stores. This gentleman in explaining the present situation, made highly derogatory remarks concerning the Jewish people. The party was communicated with, the subject matter tactfully presented, whereupon he made complete apology and gave his assurance of permanent good will, regretting sincerely his error.
- G. Reported anti-Semitic broadcasts of the —— Seminary received attention. Influential people agreed to use all possible influence to discourage such attitudes.

Professor Apologized

B. Attention was directed to the very misleading remarks included in the public address of Dr. — of — College. These remarks quoted in newspapers were to the effect that Jews controlled the world's gold through international finance; that their political influence made and unmade the cabinets of the various governments, etc. Shortly thereafter, he made public apology for his statements, expressing his extreme regret that he had been misled.

D. Complaints recorded against Rev. —, of Michigan. Several radio broadcasts by this minister viciously attacked the Jews. Authentic information of the objectionable remarks was requested. Pending.

K. Reported anti-Semitic organization in —, Ohio, was referred to Cincinnati Committee. Investigation pending.

L. Information was received from —, Illinois, with regard to discriminatory references on Post Office bulletin board. Further details are being secured.

Minister's Hostility "Fixed"

J. There was reported to the League a conversation between a young Jewish girl of — and one Rev. —, whose references to the Jews and Jewish influence revealed a most hostile state of mind. The League's representative in — acted upon the matter with entirely satisfactory results. The minister has confessed to having wronged the of Scripture. He has given his assurance to avoid similar errors.

M. The consideration of the League was requested in connection with reported discrimination on the part of the — (nationally known firm). Through close contacts with the heads of company, interviews were had which revealed that Jews were employed in the offices and on the road and that there had just been approved applications of Jews seeking employment for early engagement with the organization.

O. Correspondence with Brother Heller of Denver in connection with discharging of Jewish teacher from — College was held over pending further investigation.

Material submitted to Rabbi Solomon Freehof with reference to Dr. Otto Valbehr, prominent Nazi propagandist. Dr. Freehof agreed to prepare article answering the stock arguments being made in Dr. Valbehr's speeches. These are to be used by our representatives in situations wherein the appearance of Dr. Valbehr or others speaking in the same strain render it advisable.

Mayor Muzzled

B. The League was requested to counsel with regard to indiscreet and offensive statement made by the mayor of a near-by Wisconsin city. This was handled through our representatives, who assured us that the unfortunate statement was one which has subsequently been deeply regretted. Matter dropped.

C. Letter was received enclosing copy of circular issued by non-sectarian league for fighting intolerance). In-

vestigation of individual connected therewith revealed unsatisfactory features. No action taken.

N. Report received from Louisville representative with reference to anti-Jewish discrimination in the employment of so-called "white collar" employees. Technique and report of the Committee on Unjust Discrimination was transmitted with directions.

Communications from several parts of the country reporting publicly expressed misconceptions of Hitler's purpose and methods, and requesting advice as to proper approach. Counsel furnished in every instance.

B. An unpleasant local situation in the Jewish community, arising out of rabbinical and lay disagreement on the boycott situation was referred to the League. The parties thereto were interviewed; dangers of such differences being publicly aired was presented, and the matter amicably adjusted.

C. The League requested for advice on the several protest petitions being circulated. Matter transmitted to Cincinnati office, since B'nai B'rith petition is handled there. The possibility of securing a joint petition was presented as worthy of consideration.

Reports in reference to the announced attacks against the Jews of one Rev. — of N. J. were received. Through the National Conference of Jews and Christians, the friendship of Rev. — has apparently been won, and his assurance of goodwill secured.

A. Letter received indicating some association of United States Senator — with —— (an anti-Semitic organization). Investigations immediately instituted revealed charge without foundation.

A. Complaints against activities of one —, of —, Ohio, also received. Investigation of all circumstances indicated that the attitude of —— had been misunderstood. No occasion remained for further investigation.

German Exchange Students Out

Correspondence with reference to the activities of German Exchange Students in this country resulted in the Anti-Defamation League referring these matters to the Cincinnati office. This situation, involving international representations, falls within the purview of joint committee organized by the three national Jewish organizations.

A. Correspondence received with regard to propaganda from Germany and printed in Springfield (Ohio) newspapers. Mis-statements therein made were corrected, such corrections appearing in identical journals.

B. Complaint received from representative in —, Va., with regard to Nazi speaker addressing students at — College. — College offered speaker to dissipate baneful effects of misrepresentations. Arrangements are being made for such a speaker.

A. League assisted in securing resolutions of the American Dental Association meeting in Chicago, to protect all

dentists granted diplomas in any part of the world, regardless of race, religion, or party politics.

B. Complaint from representative at —, Pa., in re item appearing in newspaper. Information furnished for counteraction.

William S. Moe, of Lake Forest Academy, requested League for information in regard to German situation, in order that students might properly be informed. Same was supplied.

Conceptions Always "Erroneous"

Correspondence with Dean — of — University (outstanding American University) with reference to statements set forth in interview appearing in the public press. These statements conveyed very erroneous conceptions of the situation of the Jews under Hitler. A full explanatory letter was written to Dean —, and an answer was received enclosing statement given to the Harvard Crimson, making full corrections of the impressions left by the unfortunate interview.

Numerous complaints against the Martha Washington Hotel, Virginia, and the New Chamberlain Hotel, under the same management, were received and referred to our representative with definite course of action suggested.

A. Objectionable advertising of Boston & Maine Railroad and the Maine Central Railroad in connection with hotels in Massachusetts was successfully terminated by the League commissioner for District No. 1.

C. In connection with distorted statements of Rev. —, arrangement was made for presence of member of Speakers' Bureau.

D. Queries were addressed to the League regarding the advisability of using certain type of anti-Hitler propaganda in B'nai B'rith membership effort. The adverse idea of the Council was transmitted to the inquirers.

A. The objectionable activities of Evangelist —— reported to the League. Through co-operating agencies, assurance received of correction of his addresses.

Don't Classify with Negroes

Complaint against Illinois Joint Commission on Industrial Standards for objectionable statement contained in its report of classifying Jews and Negroes together. The League called attention to its inadvertent injustice and secured assurance of greater care in the future.

Report on Katherine Gibbs School, of Boston, which had informed applicants that Jewish quota was entirely filled. Investigation revealed no offensive discrimination, but a regulatory policy with regard to the student body.

"Hitler Was Perhaps Right"

Complaint against Professor — of the Chemistry Department of the University of —. This gentleman had, because of difference with a Jewish student, asserted that Hitler was perhaps right. Extensive correspondence be-

tween him and Chairman Livingston resulted in his admitting error and a very sincere expression of determination to avoid such indiscretion in the future.

In re anti-Semitic items appearing in Ferguson Forum of Texas. The Anti-Defamation League offered suggestions, which were satisfactorily followed.

Complaint against — University for refusal to admit as a student to the Medical School a Jewish boy from South Bend. Investigation proved no injustice intended; that —, as a Catholic-endowed institution, admitted Jewish students from Chicago, but insofar as outside students are concerned, its physical capacity demands that these be limited to Catholics.

Change Dictionaries

Correspondence with Rabbi David Miller, of Oakland, in re his demand for changes in the definition of the word "Jew" in various dictionaries. Rabbi Miller's approach has called forth considerable unfavorable publicity in nationally known periodicals. The Council advised that action on matters of this character be delayed.

Complaint received against prominent Evangelist because of reference made in a sermon in Des Moines revival meeting. Following interviews with representatives, she regretted objectionable statements, which, she said, had unconsciously been made.

Volume of requests for copies of Chairman Livingston's booklet on the fraudulent character of the Protocols.

Extensive correspondence with Anti-Defamation representative of Southern California and prominent movie executives with reference to the contemplated film, "The Mad Dog of Europe." By reason of the League's representations of the potential danger of such a film, the producer decided to abandon the project. Subsequent sale of movie rights led to a new effort to produce. Theater owners throughout the country were addressed, and assured us of their intent to urge the discontinuance of any effort to produce this film. Second assurance was received that the project was definitely abandoned.

"Matter Satisfactorily Concluded"

Complaints against the play, "She Loves Me Not," on the New York stage was referred to our New York representative. The objection was made to the Jewish communist character. Matter satisfactorily concluded.

Correspondence with Baltimore representative and distinguished Chairman of the Maryland Board of Censors with reference to the pronounced tendency of depicting objectionable characters as Jews. Such characters, unethical as doctors, shyster lawyers, gangsters' mouthpieces, etc., have within recent months been more and more largely assigned to noticeably Jewish types. The matter has already been taken up with our Los Angeles Committee, which is now working upon this suggestion. Letter prepared to be di-

rected to every Jewish motion picture producer as soon as directory of same is compiled. This letter is calculated not only to enlist their co-operation for the elimination of this evil, but also to fully direct their attention to the volume of unfavorable criticism resulting from the plethora of salacious and gangster plays. This criticism is particularly noticeable in the columns of religious periodicals. Upon proper representations, Mr. Fred Beetson of the Motion Picture Producers' Association of Los Angeles has promised co-operation in the creation of better films.

Correspondence in re article appearing in Culver Alumnus, and written by Dr. —, presented to us by Omaha representative. The article definitely commended the Hitler program, predicting its success. The situation commended a policy of very tactful approach which was made through League representative at Omaha. Assurance given that the writer is not a Hitler propagandist.

How to Stop Silvershirts?

Requests from Lincoln, Nebraska, as to proper method of combatting Silvershirts organization, now active in that city. Action prescribed by League. Similar requests from Oklahoma City. Representative informed us of the rapid spread of activities there.

Correspondence between the League Chairman and the editor of a most popular weekly magazine in America. This correspondence was initiated by reason of very unfortunate Jewish references in a story appearing therein. The chairman's very complete explanation resulted in the

gracious acceptance of his viewpoint and the assurance of the very fairest practice in the future.

Complaint received in reference to employment discrimination of the —— Publishing Company. Investigation revealed the reports to have been unfounded.

Time Magazine Corrected

Unfortunately worded protests to Time Magazine were called to our attention. These had been reported in the publication, and emanated from protests of a local branch of a national organization. The national president thereof was communicated with, and the danger of such actions conveyed. The response to our letter was an offer of complete co-operation of this group with the Anti-Defamation League.

Correspondence in re the Liberal Magazine and its policies and defending religious liberty and opposing intolerance of every kind. Utmost co-operation with the League assured by the editor.

At the request of a representative in Boston, the League prepared an answer to Miss Clara Laughlin's article entitled "Germany Today," which appeared in Travelers' Magazine. No response yet received.

Complaints with reference to a broadcast of Mr. Donald Richberg, counsel for the NRA, received, and correspondence had with him. Mr. Richberg's attitude was one of absolute fairness, matter resulting most satisfactorily.

Merchant of Venice Out

Very extensive correspondence with a large number of cities concerning the elimination of "The Merchant of Venice" from the public schools. The technique and method of approach was transmitted in every case, and reports of successful negotiations have been received. List of such cities hereto attached.

Protest was made to the editors of a publication of the National Fire Underwriters about an offensive item appearing in the issue of October 12. This matter was taken up with the editor, who, after correspondence, informed us that it had not been passed by the editor's desk; that in the future no such objectionable feature would be permitted to appear.

"Distorted" Viewpoint

Letter from Pana, Ill., in re distorted viewpoint expressed in editorial in *Progressive Miner*. Our Pana representative had the matter referred to him for investigation, and after interviewing influential people, advised that no further editorials of this character would appear.

Correspondence in re propaganda letter appearing in newspaper in Appleton, Wis. Draft of an answer submitted to our representative and inserted over his signature in the same column.

A highly distorted article in the Denver Post required special treatment by reason of its obvious misrepresentation. Answer was presented to the article, submitted to

the Denver Post over the signature of prominent Denverites, and given very prominent space.

Papers Can't Defend Hitler

Correspondence with —, of Texas, in re letter appearing in newspaper defending Hitler policy. Not only was our letter printed therein, but local group received very definite apology from the newspaper and assurance of strong censorship of such malacious propaganda for the future.

Correspondence in re discriminatory advertising appearing in the Shopper's Guide in Edmonton, Canada. Method of approach submitted to the representatives of that city by the League. Assurance given such practice would not be permitted in future.

Hitler propaganda appearing in Milwaukee journal was answered by special article prepared by Rabbi Freehof, of Chicago.

Special correspondence with Washington representative in re brochure by Mr. Max Kohler, of the Jewish Academy of Arts and Sciences. A substantial quantity of brochures have been prepared by the Cincinnati office. A supply was procured for distribution.

Stop Chain Letters

Correspondence with Washington representative was had with regard to possibility of restraining dissemination of vicious circulars by chain letter medium. Washington

representative requested to make thorough investigation of any possible methods. Efforts to be made to amend postal regulations to prevent, if possible, dissemination of libel and slander through mails in this country.

Protest from —, Ill., against the anti-Semitic statements of one Rev. — over the radio. Upon proper representation, minister's talks were being censored, and all disparaging statements against any religious sect have been deleted.

Further Protest "Unwise"

Correspondence with Calgary, Canada, in re Passion Play to be presented in that city. Investigation revealed that particular version containing no harmful material, and that further protest would perhaps be unwise. Correspondence with Springfield (Ill.) representative in re Passion Play contemplated for that city. The proper representations being made to Catholic priests sponsoring this play have been unavailing, and the Chicago office was requested to take the matter up from this point. Matter pending.

Correspondence with representative of Rock Island, Ill., and representative of Omaha, Neb., upon the same subject —namely, Passion Play. Investigations being made.

Complaint against —, president of a powerful farmers' organization, on highly objectionable references from platform and over the radio. Through contact in —, matter was presented to Mr. —. Representations received in friendly spirit, but offender evidently unconvinced.

Though no further effort was deemed wise, it has been noted that objectionable references have been eliminated.

Correspondence in re prevalence of Jewish vaudeville and radio stars utilizing offensive Jewish humor which now particularly is unwise. Interviews had with Benny Rubin, Lou Holz, Phil Baker, Eddie Cantor and others, all of whom definitely agreed to avoid the use of such material in their acts.

Correspondence with Milwaukee representative in re The Royal Insurance Exchange of London, reported as refusing insurance to an applicant because he is a Jew. Investigations revealed no such regulation of the Royal Insurance Company, and that this action hinged upon its particular aspects.

Consular Representative Stopped

Letter directed to Washington representative, requesting information with regard to the propriety of a consular representative distributing propaganda literature calculated to create unrest between American groups. The distribution occurred at meeting of a lawyer's group. Through efforts of our representatives, objectionable activity has been stopped.

A volume of correspondence with various sections of the country in re the broadcasts of Judge Rutherford of the Watch Tower of Brooklyn. These broadcasts received over many stations. Where possible, stations were contacted and promises of co-operation were secured. Further broadcasts will be carefully watched and time refused where

objectionable material is insisted upon. However, Judge Rutherford's organization practically controls vast chain of minor stations and, in this connection, the proper termination of this problem is more difficult. Efforts are constantly being made to secure the desired results.

Information given us of the broadcasts contemplated by the School of the air over the - Broadcasting System. Contact made with Chicago office of the - Broadcasting Company, which immediately long distanced New York in presence of League representatives and arranged for further programs to be carefully watched, that nothing appear therein prejudicial to Jewish group.

"Take Us Seriously, or Else-"

Complaints received with regard to the Goldberg program on the radio. Certain aspects were objectionable. Matter was taken up with Mrs. Berg, script author, who agreed to eliminate any material which might possibly be questionable. Mrs. Berg has ladvised our representative that she senses improved reaction to her program as a result, and will henceforth be particularly careful.

Strong objection launched against the Tasty Yeast Jesters for having broadcasted highly objectionable version of the ancient arson joke. Correspondence with the Tasty Yeast Company and the Jesters resulted in assurance that all such material would very definitely be eliminated from tuture programs.
