Week after week it thumps the tubs of fascist ideology: "Dqwn with the Jews," and "Down with Communism," the latter, concept embracing even the most modest of diluted democratic re-« forms.

The current issue of the paper reveals its hatred of progressivism, its endorsement of fascist reaction.

Allotted most space this week is the acquittal of Captain John T. Prout, Jr., by an Army court-martial on charges of having given 1,800 rounds of government rifle ammunition to the group of Christian Fronters who were tried in a Brooklyn Federal court on charges of conspiring to overthrow the United States Government by violence and terror.

Prout, with four others, still faces possible retrial in the Federal court on the same charge.

The acquittal is heralded on the front page as a "Christian" victory over a "campaign of persecution" conducted by "those who sought their pound of flesh"-all of which is part of the Aesopian language employed by The Tablet in its anti-Semitic arguments.

Prominently advertised, also on the front page, is a "testimonial" dinner given for Prout as a sort of victory celebration.

PROSECUTOR WINS PRAISE

On an inside page The Tablet publishes the full text of the statement made to the military court by Prout in which he offered a "repudiation" of a signed confession to the charge against him. Prout's statement was presented to the court under a provision which exempted him from the embarrassment of cross-examination.

In its report of the courtmartial proceedings, The Tablet praises the Army prosecutor for the "clear, objective manner" in which he conducted the case, just as, in the earlier Federal trials, United States Attorney Harold M. Kennedy was praised for his "fairness" to the defendants.

Also highly praised by The Tablet are those who appeared as character witnesses for Prout, including Miss Dorothy J. Lutjens; whom it identifies as the general manager spur to a possible resurrection of the United States Chamber of the equally detestable Klan-like Commerce, and Lieut. Col. Martin

PRAISE FOR WITCH HUNT

Equally prominently displayed in this week's Tablet is the testimony given before the Rapp-Coudert committee by Dr. Harry D. Gideonse, president of Brooklyn College, and by the prominent informer Edward I. Fenlon of Brooklyn College's Department of Philosophy, who did their best to pre-sent the committee with properlyhorrifying details of incipient "red revolution," but whose feeble bumb-lings fell flat.

Nevertheless, Dr. Gideonse's story of student picketing is described in The Tablet as a "bit of revolution equalling that seen in Spain in the Christianity."

This is serious business for The Tablet, because the paper has campaigned and tirelessly for just such an assault upon the free school system as is now being made by the Rapp-Coudert Committee with the ultimate aim of destroying academic freedom and democratic education. Indeed, The Tablet prides itself for having, in fairly large measure, inspired the present inquisition against the schools.

On this week's letter-page, the paper proudly displays in leading place a congratulatory message from the noted informer Edwin P. Banta, the man whose original stoolpigeoning on the Writers project of the WPA used to good effect in the campaign to destroy or cripple the cultural projects sponsored by the government.

In his letter, which is actually a pathetic document begging recognition for past services, Banta recalls his part in picketing radio station WMCA when Father Coughlin's anti-Semitic tirades were barredpicketing which came to a sorry end when its leader was arrested in an attempted shakedown of the station.

And finally there is a letter proudly published which hails the Prout acquittal as a "victory for Ohristianity" and concludes with the ominous cry: "Awake Christians and join the crusade against anti-
