Coughlin Paper Boasts Being 'Front' Defendant

Was 'Absent Defendant' Along With 14 Linked to Bomb Plots and Terrorism 7/7/40

Social Justice, personal organ of Father Charles E. Coughlin, this week confirms what has been known from the start: that Father Coughlin himself, though not present, was the principal defendant in the mock trial of fourteen members of the un-Christian Front. In its latest issue of July 8, the magazine gloatingly states: 'Trial Is Vindication of Christian Fronters' and proceeds with this revealing declaration: "The jury's verdict not only vindicated the 14 young men@

accused of crimes against their government, but it also cleared the Christian Front and vindicated the 'Absent Defendant'-Father Cough-(Our emphasis.)

And the threat of "wave of anti-Semitism." with which Father Coughlin himself greeted the jury's verdict of ac-quittal for nine of the defendants is given still greater weight: "Whether the Jews like it or not," says Social Justice, "they will bear more than their brunt of blame for some of their co-racials having used the majesty of government to wreak revenge upon a group of men who were intent on saving America from Communism, from Jewish domination and from semitic ideology."

SIGNAL FOR POGROMS

In this manner Father Coughlin, who was long ago disavowed by Cardinal Mundelein as representing the Church or the Catholic religion, urges his followers on to fulfill their confessed program of widespread terror and violence in the form of bombings,

Let it not be forgotten that, under all the noisy trappings, these so-called "Christian" Fronters admitted on the witness stand that they acquired munitions from a gov-enument armory, that they manu-factured bombs, that they even went so fat as to draw a map of the Daily Werker office with the avowed intention or blowing it up, that they trained themselves in rifle practice, that they advocated "knocking off" Congressmen.

This is the program that Father Coughlin hails as "vindicated" by a court of the United States. And the "vindication" is credited in no small measure by Father Coughlin himself to U.S. Attorney Harold M. Kennedy, whom he praises for his "fair prosecution."

OK OF ANTI-RED

Social Justice knows, why the nine defendants were acquitted.
"The defense," it states, "con-"The tended that the young men were merely preparing themselves to combat the expected Communist revolution. It was maintained that the accused met for the sole purpose of discussing the plans and objects of the Reds, and that they had organized rifle clubs only to be prepared for the defense of their country."

This was the "defense" whereby projected bombings and assassinations were condoned and justified, and it was a successful "defense," because the line of it coincides with strongly developed tendencies within monopoly circles and governmental agencies. Fascism always justifies every one of its violent steps forward by pointing to the mythical menace of imminent "revolution."

Social Justice this week applauds another member of the fascist fraternity which has long since justified violence against labor on the same grounds—the Chicago Tribune. Social Justice reprints in full the editorial of that paper which greeted the acquittal of the Brooklyn terrorists and denounced even the mock trial as "an instrument terrorize Americans who have recognized the Communist menace in this country."
