Fr. Brophy --- Purveyor of Nazi Race Theories Here

~ When the Department of Justice last week made it clear in Washington that it will refuse to reopen the prosecution of Christian Front terrorists acquitted in a Brocklyn court, it was in fact condoning and encouraging a Fifth Column patterned after the treacherous bands who delivered the Spanish and French peoples into the hands of Franco and Hitler.

By its decision, the Department of Justice actually endorsed the declaration of U.S. Attorney Harold M. Kennedy, who was supposed to prosecute the case, that the Christian Front is founded on "good, sound American principles,"

Apart from all the admissions and confessions of the fourteen delendants that they planned bombings and violence against "Jews" and an orgy of red-baiting terror. and had acquired munitions from a government armory to carry out their pilots, the "theoretician" of the Christian Front himself openly boasts that the aims of the organization are in violation of the Constitution of the United States and its democratic institutions.

This "ideological" leader is Rev. Edward F. Brophy of Precious Blood Church, Long Island City, who has written the only "authoritative" pamphlet entitled "The Christian Front" and who inferentially takes credit for writing the preamble and objectives of the organization.

At a Christian Front "victory rally" held on July 3, Father Brophy, one of the principal speakers, rewrote the Declaration of Independence which has freedom of worship and separation of church and state as one of its cardinal principles. "The Declaration of Independence," he shouted, "was framed by Christians for a Christian people exclusively. The founders of our nation were all Christians and the pursuit of happiness was the pursuit of Christian happiness."

Father Brophy in his pamphlet proceeds to lay an "ideological" groundwork for this pure fascist notion of exclusiveness on racial lines.

Father Brophy's "theoretical" foundation of the Christian Front is identical with the "race theories" of Hitler and Goebbels. The only slight difference is the substitution of the word "Christian" for the word "Nordic" and this is a tactical difference, not a fundamental one. And it must be borne in mind that, when used by the Christian Front and its spokesmen, "Christian" has a political, racial connotation and has no reference whatever to the teachings of Christ.
