DIES REVEALS 563 'RED FRONT' NAMES IN EMPLOY OF U.S.

Washington, D. C., Oct. 25.—The Dies Committee touched off a series of verbal explosions today when it made public the names of 563 Government employes described as "members or on the mailing list" of the American League

for Peace and Democracy. The league has been branded by the committee as "a front for the Communist Party."

There were immediate repercus-There were immediate repercussions in the committee room and on the floor of the House of Representatives because the list of 563 names did not distinguish between actual members of the league and persons who were merely on the mailing list of the organization.

He declared that the First Lady "evidently thinks we shouldn't hurt members of these subversive organizations."

His blast drew an accusation from Representative Robert G. Allen (Dem., Pa.) that he was the "white-haired boy of one subversive organization." Allen said he referred to the Silver Shirts, headed by William Pelley and avowedly seri-Semitic.

"I am not a member of any organization except the Naval Reserve," Thorkelson roared back.

Committee, a middle-aged former Communist Party member from Bridgeport, Conn., testified about two trips he made to Russia.

The witness, Andrew Smith, said

time he turned over most of his life's savings—more than \$5,000—to the Party for transfer to Russia. He said he found that Russia was "not the Utopia" he had been led to expect. "You can't go where you want to in the Soviet Union when you want to," he said. Smith said that he resigned from the Party because he believed that he would be committing a crime if he did not return to "my America" to inform workers of conditions in Russia. After asserting that "you'll find a lot of sabotage" if the United States and Russia should go to war, Smith testified that the loyalty of the American Communists would be with Russia.
