## **HEARING ON DIES GROWS STORMY**

Cox Says Attacks Made Texan a Big Figure.

ASSAILS ICKES'S CRITICISM

Rules Committee Ready to Act on Continuance of Inquiry.

WASHINGTON, Feb. 2 (A. P.) .-Representative Cox, Democrat, of Georgia, asserted in a stormy House committee hearing today that Secretary Ickes's criticism of Chairman Dies of the House un-American committee had boomeranged to make the Texas Democrat "an outstanding national figure."

Arguing with Representative Hill, Democrat, of Washington, before the House Rules Committee, Mr. Cox said the Cabinet member

Cox said the Cabinet member "went on the stump to attack Mr. Dies." This, Mr. Cox said, was "perfectly outrageous."
Told by Mr. Hill that he had no right to criticize Secretary Ickes, Mr. Cox flared:
"Why not? He certainly had a right to answer. Whether they meant to or not, they have made Dies an outstanding national figure."

Secretary Ickes once called Representative Dies an "outstanding Zany." They were then disputing the fairness of Mr. Dies's conduct as chairman of the Committee Investigating un-American Activities. The Rules Committee is considering revival of the committee, and House approval of continuing its inquiry was considered a foregone conclusion on Capitol Hill.

Action was likely later today, after a closed session to hear Mr. Dies answer various criticism.

As the Rules Committee was finishing hearings preparatory to floor debate a small group of Representatives was making every effort to prevent a favorable vote.

Representative Keller, Democrat, of Illinois, and Dingell, Democrat, of Michigan, criticized the conduct of the Dies inquiry to the Rules Committee yesterday, contending there were political motives behind the hearings last summer.

Mr. Dies indicated his refusal to consider this suggestion, and his work was upheld by several Rules Committee members, including Representative Cox.
