WASHINGTON, Feb. 2.—In a 15minute executive session, the House

wishingst 10%, Feb. 2-ml a 18-minute executive session, the House Rules Committee today decided to ignore documentary evidence proving that the Dies witch-hunters had refused to probe the Silver Shirt Legion and other Nazi, anti-Semitic and un-American outfits.

Without opposition it rushed through a resolution continuing the Dies Committee for one year through to the House floor for a limited one-hour debate tomorrow. There was no roll-call vote taken. Brushed aside in the hurried session of the reactionary Rules Committee was the detailed evidence presented by Rep. Vito Marcantonio, A. L. P., of New York, to show that Rep. Martin Dies had repeatedly squashed efforts to investigate the Silver Shirts and of Gerald Winrod, Nazi agent in Kansas.

The Tory dominated committee disregarded the testimony of all ten members of Congress who appeared during the two-day hearings to urge that the Dies Committee be discontinued.

IGNORE TELEGRAMS

Ignored were the 2,000 telegrams and 10,000 letters of protest against the Dies witch-hunt which Chairman Adolph Sabath of the Rules Committee said he had received during the past few days.

The only significant concession made by the powerful House body was to limit the time of the Dies Committee's activities to one year instead of the two originally spe-

Unless the Dies Committee's time is again extended, it will thus be unable to carry on as directly as it might wish a nation-wide political campaign on behalf of the Republican candidate for the presidency in 1940 similar to its activities in last year's Congressional elections.

Mobilized behind the drive to pass the resolution approved by the Rules Committee is a powerful array consisting of the entire Republican delegation in the House and a very sizeable number of Tory Democrats.

Opposing the Dies Committee is a small but growing number of New Deal and middle of the road Democrats who are convinced that its activities menace the entire liberal movement in this country and the Democratic Party as well.

Even some conservative Democrats have decided to vote against the Dles resolution because they believe that it menaces their party.

Indicative of this trend was the testimony of Rep. Joseph B. Shannon of Missouri who appeared in response to the request of a Negro constituent that he answer charges against the National Negro Congress. Referring to Dies, he said:

'I have nothing against him, except that I'm a Democrat."

The liberal Congressman for the most part take the position that an investigation of un-American activities is a worth-while undertaking, but that the job ought to be done by a new committee.

Rep. Kent Keller of Illinois, one of the leaders of the fight against the Dies Committee, has introduced a resolution calling for a new committee with a membership of 11.

Failing this, they will press at the very least for enlarging the size of the Dies Committee originally composed of seven Congressmen, so that it may be somewhat more representative and include some liberals.

Again and again Rep. Marcantonio clashed with Cox and the other reactionaries when he testified this morning. He held his ground so well that the committee was anxious to rush him off the witness stand and asked few questions at the conclusion of his testimony.

"It is my first contention," the liberal New Yorker declared, "that the committee heard witnesses who are themselves un-American and have engaged in un-American activities."

Refuting the denial of Walter Steele, editor of the patrioteering National Republic, to the effect that he was not a member of the Silver Shirts, Marcantonio said:
"He lied before the Dies Committee."

CITES SILVER SHIRT PRAISE

He quoted extensively from an article in the official publication of the Silver Shirts, "Liberation" praising the Dies Committee and boasting that the Silver Shirts were not and would not be investigated by Dies.

Then he read from the Dies Committee's record to show that on two occasions Dies had shut off his own investigator, John C. Metcalie, when he was going to put into the record material concerning Winrod.

The first time Metcalie was stopped was when he tried to insert in the record Winrod's anti-Semitic sheet, The Defender, and the second when he attempted to read from a Department of Justice report concerning Winrod.
