If Representative Dies or any other member of his committee wants to come to New Orleans to find out if the McCuistion arrest was made to discredit the committee or any official protection is gven the Communists here, he will be welcome. We think however, that the committee would be thoroughly disappointed in what it would find. New Orleans has never been a hotbed of Communism, and if the committee is well informed it knows that the un-American agitator has always encountered insurmountable obstacles here. Pertinent facts in the matter are these: That Philip Carey, a maritime union official, was murdered, on the streets of New Orleans six weeks ago, following a factional row in the union, and up to this tme the New Orleans police have not jailed the three attackers. Mc-Cuistion was one of the ousted officials, and by reason of the description given by witnesses, the police have been looking for him for some time. That their efforts do not seem to have been an example of alert crime detection or law enforcement, is beside any point that concerns the Dies committee. In any case, when McCuistion's presence in Washington was made known to the police, Chief of Detectives Grøsch filed murder charges against/him and asked his return to New Orleans. That was eminently proper since New Orleans is/not a city in which gang murders have become the custom, and not one disposed to let gangsterism of that kind go unpunished. We thick that if there is any question of precedence, a murder charge

The FBI later withdrew on the ground that Mc-Cuistion was in the custody of the Washington police before it intervened under the Lindberg law. Probably New Orleans citizens would be much interested to know why a request for McCuistion's detention "stinks," or what interest the local police could have in protecting Communists. Sometimes Mr. Dies seems obsessed with the idea that half the people in the country are plotting to thwart his committee's work. Perhaps if he comes here he will let the public in on the evil forces that are trying so hard to discredit his efforts. Meantime we hope McCuistion is returned here and that the police begin to get to the bottom of the Carey murder.

THE PILOT Suggest Dies Probe Murders In Gulf, Not Protect Goon

NEW ORLEANS—Joseph Rose, NMU delegate, issued today, Wednesday, the following statement in connection with the visit of Represetative Dies to the city.

"Mr .Dies might better have remained in Washington to investigate the un-Americanism of the shipowners who are trying to transfer registry of their ships to a foreign country in order to evade the neutrality legislation and to avoid maintaining an American wage scale ad American working conditions aboard their ships.

"However, since he has chosen to come to New Orleans we hope that he will really investigate the McCuisition case and not attempt to interfere with bringing to justice the murderers of Philip Carey.

"In connection with the activities of William McCuistion and his chain gang, we sugest that he look into the mysterious disappearance last spring of Robert Eggleston, former NMU bookkeeper; that he investigate the death by beating of John Syrnick, youthful member of the NMU; and that he interview the numerous victims of McCuistion's chain gang.

McCuistion's chain gang. "We suggest he go to Corpus Christi, Texas, where last June McCuistion led a gang of 20 men into the port, armed with guns, blackjacks and brass kuckles, in an attempt to wreck the Union; to Port Arthur, Texas, where Mc-Cuisition is alleged to be implicated in the shooting of an NMU member last August; or to any Gulf port and inquire into the terroristic activities of McCuistion and his chain gang against the NMU membership.

"If Mr. Dies is really concerned about civil liberties, we suggest that after looking into the shocking situatin here, that he go home to Texas and investigate the recent burning by vigilantes of the NMU hall in Baytown; the beating of an NMU organizer in Aransas Pass by Standard Oil dollar a year men; and the situation in Port Arthur, Texas, where last spring an NMU member had to seek refuge in the county jail after the city police had threatened to kill him. These are a few leads for Mr. Dies. We can give him plenty more.

"It seems most peculiar, to say the least, that Mr. Dies should come to a city where labor's civil rights have been consistently violated solely for the purpose of protecting the 'civil rights' of a murder suspect."
