Tales of intrigue as the wife of a Russian spy were related vester-day in an annulment suit filed here by Mrs. Frances Dallant, a Social Security Board nurse, of the 3700 block Massachusetts Ave.

She asked District Court to annul her marriage to Nicholas Dallant, alias Dozenberg, now serving a sentence of a year and a day in Federal Prison at Lewisburg, Pa., for passport fraud.

Mrs. Dallant explained she met Dallant in 1932 while she was a student at George Washington University here. They were married August 21, 1936, in Yokohama Japan

Dallant, she said, pretended he was a movie producer and a na-tive of North Dakota when they were married. She later learned

he was a Russian secret agent.

As an alternative to annulment of the marriage, Mrs. Dallant asked that she be given a divorce! and custody of her daughter, Ruth,

Security Board Nurse Sues Spy for Divorce

A four-year marriage with a background of international intrigue was related to U. S. District Court yesterday as Frances Dallant, Social Security Board nurse, sued for annulment of her marriage to Nicholas Dallant, alias Nicholas Dozenberg, Russian agent, now in the Federal penitentiary at Lewisburg, Pa.

Mrs. Dallant, who declared she had no suspicion of her husband's activities until a visit to Russia in 1937, told the court she met Dozenberg while she was Washington University stua George dent in 1932.

The following month he sailed for The following month he sailed for Europe and when he returned they saw each other in New York, where she was attending Columbia University, Mrs. Dallant related. In August, 1936, she followed him to Japan, where they were married. Altho Dallant told her he was divorced, she later learned that he wife was a Russian agent who. Was his wife was a Russian agent who was required not to work with him, and that the wife did not die until January, 1936, in Tientsin, China.

During the early months of 1937 the Dallants traveled on what Mrs. Dallant believed was a sightseeing tour thru France, Austria, Czechoslovakia and Germany, she related. When they fi-nally remained in Russia for two months before sailing to London, her suspicions were aroused, Mrs. Dallant

periods, Mrs. Dallant was visited by Russian officials, who questioned her, advised her against prying into her husband's affairs "provided she wanted no harm to come to her family in the United States." Dallant went to Manila and Mrs. Dallant returned to Washington, where he subsequently joined her.

Later she learned that Dallant had been arrested and admitted he was a Russian spy, she asserted.

LIVES IN FEAR

Her experiences have made her mentally and physically ill, Mrs. Dallant asserted. In addition, she said she has "lived in constant fear and has been subjected to examination by various

Government agents."

She asked for annulment of the marriage, custody of their 2-year-old child and permission to resume her maiden name, Frances Davis DeLaw-
