Axis Apologist Quizzed Again by Grand Jury

A written statement addressed to The News by David Baxter, Jap and Nazi apologist of San Bernardino, got him into hot water again with the special grand jury probing Axis propaganda yesterday.

The statement promised America a "change of political power —a political revolution." The grand jury requisitioned the state-ment and brought Baxter in for questioning. For more than a week he has been brought in for almost daily quizzing by Special Prosecutor William Power Maloney

Baxter is a spokesman for the So-cial Republic Society which flowers in the fecund soil of Southern California where almost anything grows twice as big. The group, known as the "Socis," anticipates a revolution in America, and urges its members to store up arms.

COUGHLINITE QUESTIONED



Postmaster Gen-eral Walker has ordered a hearing set for next Wednesday on a motion to make the mail ban permanent. It is anticipated that Father Coughlin, who has claimed full responsibility for the magazine, will appear personally to fight the ban, and that he will be subpenaed to appear before the spe-cial grand jury at the same time. "The New Deal sacred cow is about "The New Deal sacred cow is about to be offered upon the sacrificial altar of outraged public opinion. My reports from all sections indicate this. Govern-mental power comes not from Wash-ington but from the so-called 'back country.' And we of that 'back coun-try' are breaking the hold of official rascality.

"The New Deal Attorney General has selected as an assistant in charge of so-called 'Axis' investigations (roundof so-called 'Axis' investigations (round-ing up as pro-Axis' anyone opposed to the Administration's foreign policies) William P. Maloney, one of the 'little tough guys' of the legal profession. Maloney is tough. He not only knows the legal holds but is diabolically well-versed in the finer art of subjecting his victims to 'newspaper trials' long before they have ever been indicted by a grand jury. "However, I am not greatly per-turbed. 'I can 'take it' as long as 'my public servants' wish to 'dish it out.'

Ban On 'Social Justice' Is Extended to Newsboys By United Press

Anyone transporting or distributing seditious publications banned from the mails—railroads and newsboys alike— will be subject to drastic penalties under the Trading With the Enemy Act, Atty Gen. Biddle warned last night.

The ruling applies to Coughlin's So-cial Justice. Violators face a possible \$10,000 fine and 10 years imprisonment.
