Trial May 13

First 'Soci' Agent Indicted For Sedition in Tennessee

George W. Christians, a Tennessee link in the Soci secret organization of armed revolutionists, was indicted on four charges of sedition in Chattanooga yesterday.

Christians was the first of the known Socis to be formally accused by a Federal grand jury. If convicted, he will be liable to \$40,-000 fine and 80 years in prison. He was held in \$10,000 bail and ordered to trial May 13.

Heads Crusader Group

The Socis-who find this label snappier than their full name of Republic Society"-have 'Social been under the scrutiny of the special grand jury on Axis agents in Washington. Before the grand jur-ors for nearly three weeks has been David Baxter, summoned from his headquarters in California.

Baxter wrote much of the Soci propaganda, which he has been mailing out and which has been recirculated by agents who, Baxter says, are active in every State. One of these was Christians.

Named on Four Counts

Christians coupled his Soci propaganda with that of an or-ganization with which he made a stab at an uprising several years ago, the Crusader White Shirts, of which he is "commander in chief." What brought him to grief were

"When the mad mob gets in motion," Christians' dodgers advised his followers, "don't miss a single politician. Just HANG them to the nearest tree or lamp-post."

The indictment presented yesteray after a grand jury inquiry conducted by James B. Frazier, jr., United States attorney for eastern Tennessee, accused the Soci agent of four violations of the Espionage Act of 1917.

In violation of this act, the indictment charged Christians willfully

dodgers of the latter group, which he is accused of having mailed to soldiers at Camp Forrest, Tenn., and Fort Oglethorpe, Ga.

One of these dodgers listed questions to be asked to "create a reign of terror." One question was, "Do Germany, Italy and Japan have the right to fight for freedom from OUR economic strangulation?"

Another dodger said President Roosevelt was a "merciless mon-

of Baxter and suspected confederates of the Socis, the prosecutors hammered at the operation of Charles E. Coughlin's weekly magazine, Social Justice, already barred from the mails pending hearing Monday on a final order.

Editor Before Probers

Heard yesterday were E. Perrin Schwartz, the nominal editor, and three young women employed in the offices of the Church of the Little Flower, Royal Oak, Mich., where Coughlin is pastor. They were Eugenia Burke, private secretary; Marie Rhodes and Bernice Marks.

In violation of this act, the indictment charged, Christians willfully tried to foment disloyalty and mutiny in the armed forces and to discourage enlistments.
