"Several thousand copies of Roosevelt Tours, Inc.," were produced, in several printings," Stratton said. "Mr. Dennett had some. We sent him quite a number some time ago; it was in the spring or early summer, I think. But I don't recall sending any to the America First Committee. Of course, we got a number of requests, but I do not remember sending any to America. First, as an organization."

Stratton said he never authorized anybody at Ossining, N. Y., to mail his frank, as far as he knew. An Alexandria woman recently received the Roosevelt Tours card from the New York prison town.

Stratton said that some copies of his franked item, "Letters of Thomas Jefferson," were sent to Dennett, but that he could not recall sending any to the America First Committee.

"Of course," Stratton commented, "we have no control over the material after it leaves the office. But Lishould hate to think of it being burned, or anything like that. That would be a waste of money and time, as well as of paper and ink. I certainly have not counternanced anybody burning any of my reprints from the Record."

Meanwhile, franked material figured briefly in the Senate yesterday, where Senator Gerald P. Nye (Republican), of North Dakota,

said he would "be the last to contend that there had not been, perchance, some misuse."
"For my own part," Senator Nye added, "I would have to plead guilty, as I look back now, to having been rather careless upon occasion with the frank myself."
However, Senator Nye continued that officials who criticized misuse of the frank ought not to misuse it themselves. He quoted from a speech by Secretary of Interior Ickes which he said was sent out, "to the publishers of the country, at least," under the official frank of the Secretary.

Senator Nye was one of those whose unaddressed franked envelopes were found in Dennett's office and in the mailbags spirited away from there.

The special grand jury on the

night of September 18 summoned night of September 18 summoned Prescott Dennett, secretary-treasurer of the antiinterventionists Make Europe Pay and Islands for War Debts Committees, which the grand jurors later charged were set up and financed by the ace German propagandist, George Sylvester Viercek, so he could use them to have propaganda sent through the mails under Congressional frank.

Early the next morning, on Friday, September 19, Hill sent a House truck to Dennett's headquarters, 1430 Rhode Island Avenue Northwest. Dennett loaded 20 mailbags, containing about a ton of unaddressed franked matter, in the truck, which delivered a dozen bags to the America First Committee and the other eight to the House Office Building. Hill ordered the latter consignment placed in a storeroom used by Representative Fish.

When served with a grand jury subpena, Miss Isabel French, America First office manager, gave up only ten bags, which were taken to the grand jury and later to the Department of Justice for analysis by the propaganda squad.

The other eight bags remained in the House storage room for more than a week. When ordered by the court to produce them, Hill first failed to do so, contending that he had no control of the bags because Representative Fish's office "never accepted them." This was what Fish told the House in a speech upon a point of personal privilege.

However, when contempt of court proceedings were started against Hill, he had the bags sent to the grand jury and was called back nimself for the questioning which is to be resumed this afternoon.

Representative Stratton told The Post last night that he could not recall having sent any copies of either "Roosevelt Tours, Inc.," or "Letters of Thomas Jefferson" to the America First Committee.

Prosecutors in Nazi Inquiry Study Ashes For Use in Evidence

As the special grand jury on German agents, probing deeper into mailing of propaganda under Conmailing of propaganda under Congressional frank, grilled Representative Hamilton Fish's secretary, George Hill, for the fourth time yesterday, about 2000 pieces of franked material were being burned, one by one, in an alley behind the headquarters of the Washington America First Committee of ington America First Committee at 1712 Connecticut Avenue.

Only 10 of 12 mail bags of franked material, demanded by the grand jury from the American First Committee, have been delivered. United States officials immediately ex-pressed interest as to whether the burned material was that which had been in the two missing bags, rais-ing the question of whether there had been obstruction of justice.

Destroyed on the eve of sensa-tional new developments in the German agent investigation which already has brought two indict-ments and one conviction, the burned franked material included:

"Roosevelt Tours, Inc.," a post-card with the frank of Repre-sentative William G. Stratton (Republican), of Illinois. "Three Warnings!" a postcard with the frank of Representative


