"THIS IS WAR?" No. 5.

... and the American fascists are fighting for power.

Six months ago the Japanese bombed Pearl Harbor. During the six months that our armed forces have been fighting for us in the field, our native fascists have fought against us at home. Now, after half a year, it is time to review the struggle here in America in order to see how the battle is going and where we must concentrate our efforts in the months to come.

The attack of our American fascists is two-fold: First, the attempt to break down the morale of our people by seditious and lying propaganda designed to create fear, confusion and mistrust; and secondly, to infiltrate our armed forces, our defense industries and, especially, our government.

For the first month or two the fascists had it all their own way in the propaganda battle because of the Administration's natural desire to preserve pre-war civil liberties. But the increasing boldness of the pro-Nazi press made more restrictive measures necessary. Accordingly, Social Justice, The Galilean, The X-Ray and The Philadelphia Herold were barred from the mails, and others will probably follow.

The publishers and editors of these seditious papers have been investigated and some of them are now in jail. Others are awaiting trial, although most of them continue their activities while out on bail.

Many of the subversive and isolationist groups disbanded after our declaration of war against Japan and ceased their public operations. However, a considerable number of them still carry on undercover work, although their influence is much less than when they reached the public through large mass-meetings and radio broadcasts.

The infiltration tactics of the native fascists have been moderately successful. There has been a considerable influx into the army and navy, army and navy intelligence services, service clubs and defense industries. It is true that most of those who are discovered and exposed are subsequently dismissed, but evidently there is need for a much more thorough investigation of war-time personnel.

What is, at present, the most disturbing development in this struggle for power is the announced candidacies of such pro-fascist leaders as Gerald L. K. Smith, Gerald Winrod, Jacob Thorkelson and Leon de Aryan for Congress. The danger to our democracy which would result from the election of these men, together with the reelection of Clare Hoffman, Ham Fish, Stephen Day and others of their sort can hardly be overestimated.

To summarize: We are winning the propaganda battle; the government is trying to weed out subversive elements in our armed forces; our chief danger, therefore, is that the next Congress may get into the hands of those who will impede our war effort, sabotage the peace and try to create a fascist state.

Washington cannot protect us from this danger. The responsibility rests with the people of the United States.
