and insists that this special session, if cardware played properly will help you
 in more ways than one-----It will convince the public that you and he both are
 and have been right, furthermore it will thoroughly advise the public that Dies
 and the F.D.R. Machine have conspired to wreck this National Form of Government..

and haven't crowded you for that reason-----However I believe as the Doctor does

that now is the TIME to really crack down, and to do it right-----Neither he or I have
 been asleep for the past month or two, and now that the time has arrived for some

real action, and a chance to "get out from in under " I am and he is doing all that

is possible to further your interests-----

 at Baltimore the preceding day and I receive it directly from ROSS MASTERS--There

is therefore no chance for tampering there..

SAFE to proceed as he suggests--I believe that you trust me to that extent--I
