Subject---Dr. Thorkeelson---Liberation---Quotes--- Alaska correspondence

"A"---This date I had quite a lengthy interview with The Doctor at which time he again expressed approval of your using his remarks in Congressional Record in pamphlet form---His remarks of late are plenty hot,; The One yesterday referring to The Dies Committee was "to the point", and the crowning achievement will be introduced into the record on Tuesday October third---I feel that he is gaining much ground, and the unverified bond between you and himself, has neither hurt you or him---It is "rather" suspected that there is some little friendly collusion between friends---As one man puts it---"What one says, the other proves."---

"B" *****Just a little request from The Doctor---He is not mad about it---But would rather that you would not refer to quotes ---or to meetings---explaining that he can and will do you more good, letting Congress or the World "suspect" friendship or anything they choose, but not (at this stage of the game) give anyone anything to shoot at---He wants you to begin to "cash in" on publicity and printing, and will do anything in his power to assist, but feels that certain persons should be forced to guess at "whether there are friendly relations"---for one reason, because of the printing of the pamphlets---He wants you to get the benefit of his requests for speeches---referring requests to you etc....For example he to-day requested me to turn over to you a \$100.00 job requested by a personal friend of his---the details of which are as follows:-----

"C"---Mr. J.S. Robbins---Arctic Circle Exploration, Inc.,---Candle, Alaska..addressed The Doctor enclosing \$100.00 for congressional records--reprints offering to defray said expense-----The Doctor returned the check and instructed me to have you send him (Robbins) the following letter, worded, as follows--- "We are in the process of ~~restrained~~ disseminating patriotic literature in Alaska, and thruout The United States, such as speeches by congressmen, and other patriotic citizens.

Your name comes to us thru our efforts in locating interested and patriotic citizens in Alaska.

We are enclosing a book which includes all of Dr.Thorkelsons remarks in Congressional record for your opinion to-gether with our prices on same,to-gether with prices on other printed matter.

Trusting that the book meets with your approval and that you may feel that the work may justify your order for a number of these books at an early date,as well as the new pamphlet now being printed,containing Dr.Thorkelson's recent "Special Session Remarks",we are,

NOTE-----Please address your letter to him,so that it will reach him the later part of next week(About Oct.6 th.or 7 th...Also requested by Doctor,because the Doctor has this date returned the \$100.00 to Mr.Robbins-----Don't under any circumstance SAY THAT THE DOCTOR requested you to write the man-----The Doctor took care of that in his letter to him,wherein he exp ained that the printing was being done by A PUBLISHER-----The Doctor is a member of The Artic Circle Expl-oration Inc.,therefore is remaining "in the clear on this"....He wants you to get the business however-----Am sure you know that he is,really "playing ball"---No one in his position could or would DO MORE-----Please drop him a line of a personal nature,advising him of his message to you,regarding no future mention of interviews or dates in Liberation---I do want you to continue with him,because he will furnish the barrage and defense for you when and if you most need it---Send it sealed thru me at Springfield---mention the Alaska matter also---He is really trying to increase your business,and place himself between you and further injury on the hill---He wants to do it HIS WAY however---Personally I don't thinkthe publiuity hurt anyone,but he is maping a campaign,which if it works out,will save a lot of us from being hurt.....
