New American Game: Fight \$30,000,000 Nazi Propaganda Machine Here

(Editor's Note: This is the first of a series of three articles showing Nazi propaganda infiltration in the United States, how it's done, what is being done about it and what needs to be done, based on information from the Justice Department and the Special Federal Grand Jury now investigating subversive activities.)

Opposed by a \$30,000,000 battle fund dedicated to hasten the arrival of Hitler's new order in the United States, a scant but determined handful of American citizens proudly expect to hang up a "V for Victory" over Nazi propaganda artists and money.

STATEMENT BY MALONEY

Let Mr. Maloney take over here and tell you the story:
"There's better than \$30,000,000 on

deposit in the United States today dedicated to destroying the American way of life thru propaganda for Hitler and his war machine. We can't touch it because it's American money, raised in this country, and doesn't leave this country.

"The source? Gifts; money raising stunts; business donations from some Americans who honestly believe in the Nazi methods; some who contribute because they hate the Jew; some because they're just simply stupid. But they are American citizens.

"Our so-called propaganda squad is the first time any single outfit has had the authority to go over the whole nad the authority to go over the whole picture. It is more than amazing; it is astounding what we are uncovering. Now that we can deal with the whole picture, instead of just biting off a little hunk here and a bit there, we are getting into one of the most intricate machines I have ever seen. AFTER KEY MAN

"Like a lot of other Americans, I had no idea that German propaganda artists could make such headway in this country. I pooh-poohed the idea, with the rest of us, before we took the with the rest of us, before we took the trail and have been following the gitrail and ramifications. The Germans are doing a wonderfully clever job, by indirection. indirection.

"We hope to get our fingers on the key man; there is one, somewhere. We are going after only the top men, althowe may, as we go along, spear a little lish once in a while.

"This job is long over-due. Hitler has functioning in this country today the same type of machine he had in Norway, Holland, France and other European countries to build the foundation for his later military invasion.

"The average American in the street would be horrified at the manner in which the campaign is co-ordinated; at the agencies which are linked in with the Nazi machine; many of them with the Nazi machine; many of them anknowingly helping Hitler; quite a few that apparently not only konw it but like it. They are the ones we are after first.

"I believe that when the people water

"I believe that when the people wake "I believe that when the people wake up to what's going on, they'll see the rital necessity for weeding it out. I snow that is the aim and intention of the special grand jury and the Department of Justics."
