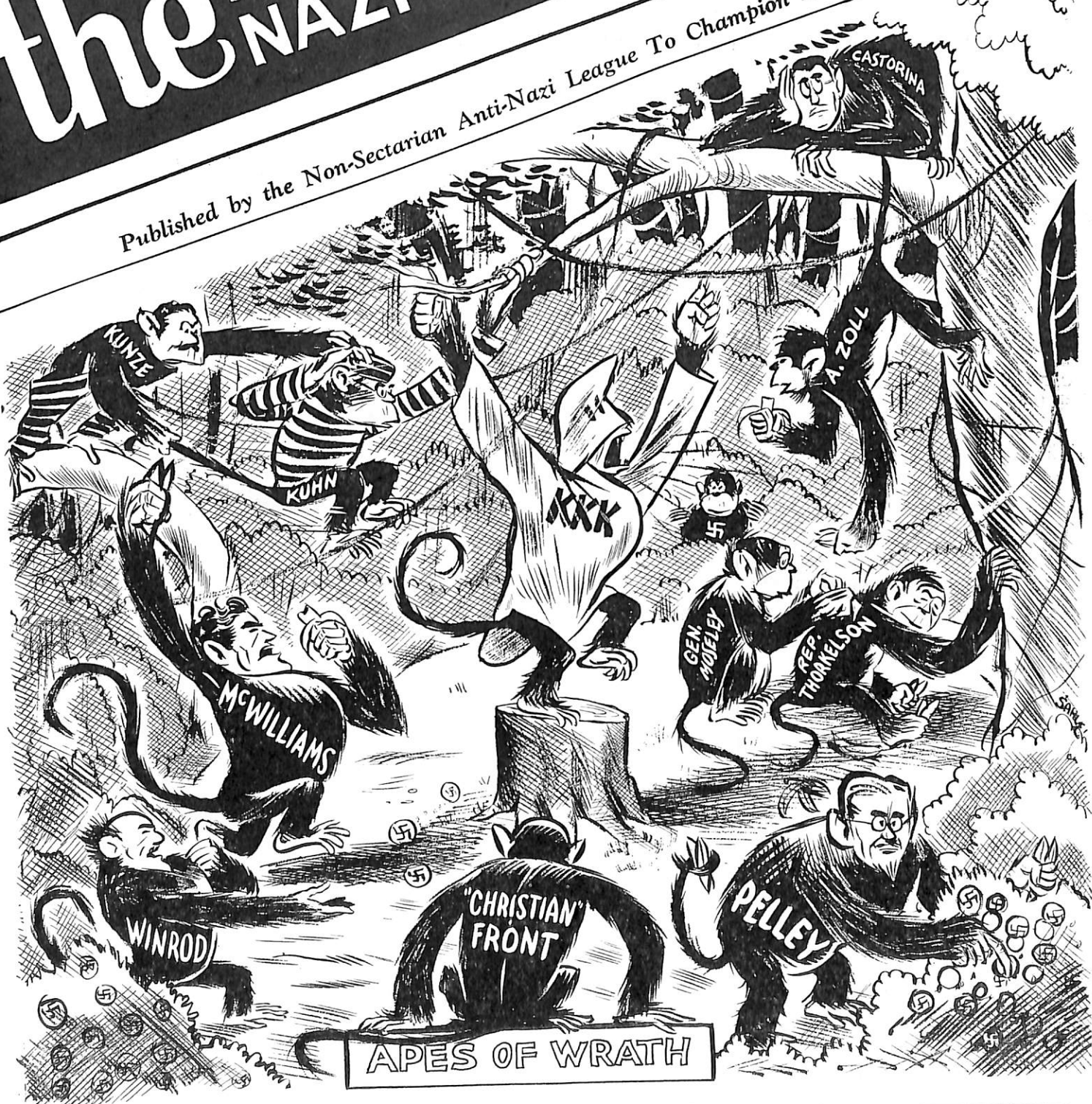

N. S. A. N. L. ORGANIZATIONS' COUNCIL CONDEMNS COMMUNISTS

A STRONG CONDEMNATION of Communists both here and abroad as "blood brothers of the Nazis" was voiced by the Council of Organizations of the Non-Sectarian Anti-Nazi League meeting at Pythian Temple. Over 300 delegates representing 150 organizations affiliated with the League packed the hall to pass unanimously the resolution which also identified the Soviet and Nazi governments as allies cooperating morally, economically and in an indirect military way.

The Council also adopted a resolution expressing sorrow at the passing of the Founder and former President of the N. S. A. N. L., Samuel Untermyer.

Another resolution condemned "super-patriots masquerading under such high-sounding names as 'Christian Front,' 'Christian Mobilizers,' 'American Patriots' and others spreading violent Nazi propaganda, including the hatred of our democratic form of government."

The conference was presided over by Dr. Benjamin Dubowsky, Chairman of the Executive Committee of the N. S. A. N. L., who welcomed the delegates and in a brief address, pointed out that the present blockade of Germany was, in a sense, a stamp of approval of the original anti-Nazi boycott. He urged all Americans not to "sleep peacefully" while the danger of Nazism and Nazi-inspired groups increases, but to work together to stop the tide of Fascism before the situation grows more acute.

Dr. Max Winkler, Professor of Economics at the College of the City of New York and noted authority, asserted that concessions to Germany should never have been made. He pointed out that every concession inevitably led to new demands and finally culminated in the present war.

A. L. Malkinson, publisher of the Jewish Morning Journal, spoke on the role of the press in combatting and exposing Nazi-inspired groups, stressing the importance of keeping the public aware of the dangers in the present situation.

"Hate, Inc.," a new kind of corporation, was described by Morris D. Forkosch, of the Legal Committee of the N. S. A. N. L.: President, Adolph Hitler; vice-president, Joseph Stalin; treasurer, Benito Mussolini; corresponding secretary, Father Coughlin. Mr. Forkosch told of the legal activities of the N. S. A. N. L. in combatting activities of Fascist groups here.

Other speakers included Gerhard Schroeder, Secretary of the Organizations Council of the N. S. A. N. L., who reported on the work of the Council; and H. Wieland Bowman, until recently Public Relations Director of the N. S. A. N. L., who vividly described the network of espionage and propa-

ganda set up by the Nazi government all over the world. Louis Schiffrin was chairman of the Resolutions Committee. The text of the resolutions follows:

RESOLUTION No. 1

WHEREAS, the U. S. S. R., since the advent of Hitlerism as a world menace continued to trade with Nazi Germany to the amount of many millions of dollars annually, and

WHEREAS, since September, 1939 the Soviet Union officially joined the Nazi Government in plundering independent neighboring states, placed itself and all its resources openly on the side of Nazi Germany and is giving its full moral, economic and indirect military aid to Hitler's war of conquest, and Hitler's crusade against the remaining democracies of the world including the United States, and

WHEREAS, all members of the Communist parties in all countries including the United States have openly endorsed this fusion of interests between the U. S. S. R. and the Nazis, have abandoned their opposition to Nazism and Hitlerism and are attacking and villifying the democracies, just as the Nazis do,

BE IT RESOLVED that this conference of organizations affiliated with the Non-Sectarian Anti-Nazi League to Champion Human Rights condemns the Communists as blood brothers of the Nazis, sees no difference between the two, except in the color of their shirts, and pledges itself to continue its fight for democracy and human rights against all enemies irrespective of the difference in color or name.

RESOLUTION No. 2

WHEREAS, for the past few years groups of super-patriots masquerading under such high-sounding names as "Christian" Front, "Christian" Mobilizers, American Patriots, and others are spreading violent Nazi propaganda, including the hatred of our democratic form of Government and the spread of Hitler's racial theories, and

WHEREAS, these subversive groups claim that they are fighting to protect the United States against Communism but definite proof conclusively shows that these groups are aided and abetted, and in some instances partially or wholly financed, by the Nazi propaganda department in Germany and by its agents in the United States; and,

WHEREAS, the Nazis and the Communists, both in Europe and in the United

1939

- May 2—Maxim Litvinoff is ousted as Soviet Commissar of Foreign Affairs and is succeeded by M. Molotov. This move caused confusion in the capitals of Europe but England and France proceeded to attempt to align Russia and the lesser nations of Europe in a collective security pact.
- June 1—Hitler guarantees the borders of Yugo-slavia.
- June 2—Pope Pius XII receives assurances from diplomats of a

BE IT RESOLVED, that we, as delegates to this Conference of the Organizations Council of the Non-Sectarian Anti-Nazi League condemn these subversive groups, praise this League for the splendid work heretofore accomplished, and recommend that the Non-Sectarian Anti-Nazi League continue to investigate and expose these subversive groups as enemies, malefactors, and attempted destroyers of these United States.

RESOLUTION No. 3

WHEREAS the Non-Sectarian Anti-Nazi League to Champion Human Rights, is deeply grieved at the passing of its founder and former President, Mr. Samuel Untermyer, who was the first among influential Americans to recognize the menace and the threat of Hitlerism and Nazism to human rights the world over and who was the champion of the anti-Nazi cause; and

WHEREAS we, who continue this fight, will always cherish his memory and value the inspiration his leadership gave us and believe that as long as the fight against Nazism and for human rights and justice continues, the name Samuel Untermyer will be inscribed indelibly as one of the pioneers of this movement,

NOW THEREFORE BE IT RESOLVED that this Conference of Organizations affiliated with the Non-Sectarian Anti-Nazi League express its deep sorrow at the passing of its beloved founder and former president (and directs that a copy of this resolution be suitably inscribed and forwarded to his family).

"firm determination to maintain peace" on his Name Day.

- June 3—Germany obtains an air base in Trinidad in return for re-arming Bolivia.
- June 12—Nazi authorities arrest Polish customs officials and charge them with espionage. Berlin papers start propaganda campaign against the Poles.
- June 18—Propaganda Minister Goebbels announces in a speech at Danzig, "no power can bar the inevitable reunion of Danzig and the Reich."
- June 29—Lord Halifax, states at London, "in the event of further aggression we are resolved to use at once the whole of our strength in fulfillment of our purpose to resist it."
- July 10—Prime Minister Chamberlain, in the House of Commons announces that Great Britain will fight for Poland in the event of political or armed aggression in Danzig. Poland suggests a Polish-German guarantee of Danzig's independence.
- July 14—President Roosevelt asks Congress to repeal the mandatory embargo provision of the neutrality act.
- July 17—General Sir Edmund Ironside, British Chief of Staff arrives in Poland for a meeting with Polish army heads. A. P. reported that 40 German army trucks entered Danzig via E. Prussia during the night.
- July 18—2,000 members of the Versuchungsgruppe (special unit of the Nazi Storm Troopers) enter Danzig.
- July 20—A Polish soldier is shot by a Danzig customs official.
- July 26—U. S. denounces the U. S.-Japanese trade treaty of 1911. Berlin streets cleared for a special air defense test.
- Aug. 4—William Strang, special British envoy to Russia is announced returning from Russia without the hoped for British-French-Russian alliance.
- Aug. 6—Polish General Smigly-Rydz announces that "violence must be resisted by force."

Duke and Historian
Not Here for Health

ALTHOUGH Duke Carl Eduard of Saxe-Coburg-Gotha is in the United States because of his connection with the Red Cross, and for no other reason, his first call upon his arrival at San Francisco recently was on Captain Fritz Wiedemann (exposed in the January BULLETIN).

But Nazi propagandists here are not hesitating to take advantage of the Duke's visit to our shores. Last Sunday, under the auspices of the "American German Aid Society", a reception for him was held in a park near Los Angeles, to which prominent local citizens were invited. Many of the people who sponsored the affair are also connected with the notorious Deutsches Haus in L. A.

Another eminent German, Dr. Alfred von Wegerer, an historian of considerable eminence, is also touring through the United States. Upon his arrival at San Francisco, he, too, contacted Captain Wiedemann as well as many West Coast Nazi sympathizers.

There seems to be no urgent reason for Von Wegerer's visit to the United States at the present time. The State Department might be interested in making sure that the historian does not need to be included in the list of foreign agents as required by the McCormack Act.

Friendless Aliens HARRIED BY SENATOR REYNOLDS

"Alien-Baiters" Use Hitler Technique

THE TRADITIONAL hospitality of his home state, North Carolina, seems to have been forgotten by Senator Robert R. Reynolds, that Southern gentleman of the old school who is foremost proponent of the more than seventy anti-alien bills now pending in both houses of Congress. The "American Vindicator," of which Senator Reynolds is President and Editor and which also happens to be the organ for the Senator's "Vindicators," an organization of 200% Americans, has gone in for plain and fancy alien-baiting which rivals in its vicious appeal to ignorance and intolerance, the platform of the 19th century "Know-Nothings."

The alien-baiting of the "American Vindicator," incidentally, contains strange undertones which strongly suggest baiting on a more widespread scale. But publicly, at least, Senator Reynolds has confined himself to denunciations of the "alien menace" and—any resemblance being merely coincidental—to fulsome praise for Nazi Germany.

The Senator undoubtedly feels very strongly about the "aliens taking away our jobs," though considering that he doesn't come up for re-election until 1945, his own position is not yet in danger. But as can be adduced from a speech he once made in the Senate, he is sometimes driven to distraction. In the course of this oration, Reynolds announced that "more than one-third of the people of America are out of employment."

40,000,000 Unemployed

Assuming that the Senator was referring to employables—otherwise why mention it—that makes 40,000,000 unemployed! Later on in his address, Senator Reynolds, with some inconsistency, referred to only "12,000,000 men and women out of employment," thus getting rid of 18,000,000 burdens on the community at one fell swoop.

Senator Reynolds, together with the other sponsors of anti-alien legislation, have not bothered too much with facts and figures in presenting their "case" to the American public. In fact, most of these bills were brought up with as little publicity as possible, in an attempt to push them through before their dangers could be realized.

The most significant provisions of the bills, some of which are close to passage, are the following: deportation of all non-citizens and exclusion of all immigration; deportation of non-citizens whose presence is "inimical" to public interest; deportation of those with "evil reputations"; deportation of those who belonged to proscribed organizations at any time in the past; deportation of non-citizens on relief for six

months during the past three years; registration and finger-printing of all non-citizens; registration of American-born children of non-citizens and deportation for failure to become a citizen.

These are the more dangerous anti-alien bills now pending in Congress, likely to pass:

1. Reynolds Bills: Provide for establishment of a passport system and for strict police surveillance of all aliens. Also restrict or prohibit quota immigration. These bills would virtually mean the establishment of the kind of police registration system found in many European dictatorships.

2. Hobbs "Concentration Camp" Bill: Provides for internment of deportable aliens unable to get passports. Already passed by House.

3. Smith "Gag" Bill: Provides for fingerprinting and deportation. Contains a federal "criminal syndicalism" clause which can be applied to citizens.

4. Dempsey Bill: Provides for deportation of aliens who belong to organizations which advocate constitutional changes in our form of government. Already passed by House.

No Reason

The facts show that there is no reason at this time for the passage of any of these bills. Our present laws make full provision for handling aliens who may be dangerous to society and provide penalties including deportation, for infringement of our laws. The other argument advanced by the "anti-alien" which would have us believe that aliens are "swarming" in, is completely falacious.

There has been no change in the immigration laws in favor of increased immigration since 1928! The publicity given to many refugees reaching our shores has made it seem that there had been an "influx" of them, but statistics show that a greater number of emigrants left the U. S. during the past few years than the number of immigrants admitted!

Drop in the Bucket

Not only do employable immigrants coming here add up to no more than a mere drop in the bucket of our jobless, but many of them actually have developed new enterprises through techniques hitherto unused in the U. S. and aided in creating new jobs.

But it is probably useless to attempt to convince the alien-baiter on a basis of fact. It is probably equally vain to show him that America has been built on traditions of hospitality to the unfortunate and oppressed and has continually replenished its energy and culture by absorbing the talents and creative ability of the immigrant.

Alien-Baiter Un-American

Pretending to be a 100% American, the alien-baiter either has no real understanding for what constitutes Americanism or is motivated by a desire to pervert American democracy through the use of the identical "appeal to ignorance" method which Adolf Hitler found so helpful in his rise to power.

The American Committee for Protection of Foreign Born, a notable organization headed by author Ernest Hemingway and the equally eminent educator, Dr. William A. Neilson, recently held its annual convention when methods of counteracting the anti-alien laws were outlined.

Danger to All

More significant, perhaps, than the danger to the alien in these bills is the danger to every minority and to all of us. The first step is to get the most unprotected group, which happens to be the foreign-born. The next step is easier because a precedent has been established.

Thomas Jefferson, in condemning the tyrannical Alien and Sedition Laws of his day, stated: "The friendless alien has indeed been selected as the safest subject of a first experiment, but the citizen will soon follow."

WHEN PAUL CASTORINA organized his American Fascist Party, later transformed into the American Union of Fascists, he found it tough sledding at first, raising enough money to issue literature and defray the expenses of a fairly elaborate organizational set-up. He originally formed his "Party" as a kind of one-man Fascist group whose principal appeal lay in its extreme anti-semitism.

The literature which he issued, and still issues, consisted of some of the most vicious anti-semitic diatribes ever to have seen the light of day, vying in untruths and distortion of fact with the mouthings of the great Dr. Goebbels himself.

Which Came First?

It is not possible to say if the formation of Castorina's group was preceded by encouragement and financial support from various influential sources or if such support followed. But whether the chicken or the egg came first is relatively unimportant. Certainly there is documentary proof—in the hands of the League—that Castorina soon found himself a valuable link in the far-reaching plans of Italian propagandists in the United States. The American Union of Fascists became one of the key organizations formed to promote Fascism among Italian-Americans.

The forces working for Fascism in the United States are sufficiently intelligent and far-seeing to appreciate the difficulties of building up a Dictator in a land where so many racial minorities demand free expression. Though at some not-too-dis-

tant date they hope to bring forth an American Fuehrer, in the meanwhile they are content to work quietly with various national groups, instilling the virus of Fascism into each one.

These sinister forces are also clever enough to know that their puppets must

never realize they are merely acting as a "Front"—even if they should come to power! Castorina makes the ideal puppet.

Adolescent Years

While he was still at school, during the adolescent years so important in molding personality, Francesco Paul Castorina, son of poor immigrant parents who brought him here from Italy when he was only two, somehow became impregnated with the vicious, perverse ideas which were to change his life and turn him into a fanatic potentially as dangerous as any of the better known Fascists now cutting their swathe through our Democracy.

Already during those uncertain formative years when even an adjusted lad finds

it difficult to get along without sympathy and advice, the young Castorina, beset by poverty and perhaps by the realization of his inadequacy in an unsympathetic world, had found an escape through a dream-world of fantasy. In this world which he built up for himself, he was always the Hero, acclaimed by admiring multitudes waiting breathlessly for a word of praise from their Leader.

Inflated Ego

It is not too difficult to understand how Castorina developed the inflated ego which today makes him certain that he is destined to be the American "Leader on the White Horse"; neither is it difficult to understand why many people dismiss him as a deluded crackpot, presenting no real danger. "Solo," year-book of Manhattan High School for Aviation Trades, which he attended, selected him as the "Class Pest." In the "Class Prophecy," his schoolmates humorously looked toward the time when "P. Castorina is arm-raising aide-de-camp (stooge) to Uncle Mussolini."

"Casteroil Castorina"

It is perhaps significant that the most cherished possession of "Casteroil Castorina," as he is famil-

iarly known to his not-too-many friends, is a letter from General Francisco Franco, the Spanish pocket-edition in small type—a very small type indeed—of the Italian dictator, no great work of art to start with. You can see how Castorina's mind must work: Mussolini to Franco to Castorina to the American people.

Even assuming that Castorina is merely a crackpot whose dream world makes him a better subject for a psychologist than a sociologist, we must not allow ourselves to fall into the grievous error of underestimating the danger of a fanatic with a single-track mind. That the track leads to a dead-end is irrelevant, for it is this type of single-track individual obsessed with an *idée fixe* who provides the human ammunition for the men behind the scenes.

Following Hitler's precept to the letter, the propaganda issued by his Fascist Union is based on lie after lie, presented so boldly that an unknowing victim says to himself in effect:

"What they say must have some truth in it . . ."

Italian Agents

Italian agents had been active in the United States for many years previous to the suddenly acquired anti-semitic platform of the Mussolini government. But in 1938 their activities were intensified on orders from Rome. The formation of the German-Italian-Japanese axis resulted in a concerted propaganda and espionage drive all over the world and particularly in the United States.

Sabotage

One of the reasons for this drive was not so much propaganda as it was the development of organizations and individuals which could be used as the nucleus for an elaborate spy-system in case of war. These groups were to be a "Fifth Column" here, with two principal objectives in view: 1—Sabotage of key industries supplying munitions to the Allies; and 2—Sabotage and possible civil war if the United States should be drawn into war on the side of the Allies.

The consuls of foreign governments in the United States are supposed to watch out for the interests of their nationals and for their country's commercial investments. The German, Italian and Japanese might do well to remember the exact nature of their duties. Our federal laws now provide for registration of foreign propagandists!

Stay Inconspicuous

Italian agents manage to remain fairly inconspicuous as far as their propaganda activities are concerned—despite the now generally admitted fact that the comparatively recent anti-semitism of many deluded Italian-Americans came about as a result of the deliberate fostering of this un-American prejudice.

Keyman in the Italian propaganda network is one Erminio Turcotti, of the Circoll Della Stampa. His exact address is 7 Viale Monte Santo, in Milan, Italy. A mysterious figure whose extraordinary powers somehow seem to make it possible for him to keep in touch with "consular agents" all over the world, he presides over meetings of a semi-official government propaganda council.

He is in direct contact with the U. S. Fascists of New Jersey, another "American" group very close to the Bund. Head of the New Jersey unit here is Antonio Carridi, who has spoken at Bund meetings and otherwise cooperated with Fritz Kuhn and Wilhelm Kunze.

Another mysterious figure in the United States is a certain Commendatore Mario Lauro, an attorney who has offices in the same building as the Italian Consulate.

National Guard

Castorina's former membership in the National Guard and the fact that a good proportion of the membership of the American Union of Fascists at one time or another also belonged (and still do belong) to the National Guard, makes the group particularly strategic. More than propaganda is the aim of the men behind these subversive movements.

If the United States should be drawn into war, these groups can spring into action overnight, prepared to sabotage and destroy the morale of the military forces by creating civil strife at home.

Remember—there is a chain which leads from New York to Milan to Rome to Berlin!

To complete the picture of the interplay of anti-democratic forces using Castorina and his American Union of Fascists for their sinister ambitions, let us not forget that the Nazi espionage and propaganda systems have extremely close connections

with Oswald Moseley's Blackshirts in England as well as with the Canadian Union of Fascists, both of whom are in turn linked to the American Fascist Union.

Castorina has to some extent patterned his organization on Moseley's Blackshirts. They are in close communication: the American Union's organ, "Blackshirt", exchanges advertising with "Action", the British Fascist publication; and the British group buys large numbers of Castorina's paper.

Fascist Party Member

Although posing as an "American" leader, Castorina is a member of the Fascist Party of Italy! His membership card, reproduced on the back cover, and his letter, explaining the duties of a member of the Fascist Party, are sufficient commentary on his patriotism.

Castorina hasn't missed a trick. As a member of the "Christian" Front, in addition to his position in all the other un-American groups, he has made some of the most violently anti-democratic and anti-semitic speeches of any of the Front orators.


North of the Border

Even closer is the link between the Canadian Fascist Union and its American prototype. Jay Villon, who represents Adrian Arcand, Fascist leader north of the border, has spoken at meetings here in New York including one at the old

Hippodrome, together with Castorina, pledging his support which turned out to mean considerable financial aid. Maybe that's why they tore the Hippodrome down.

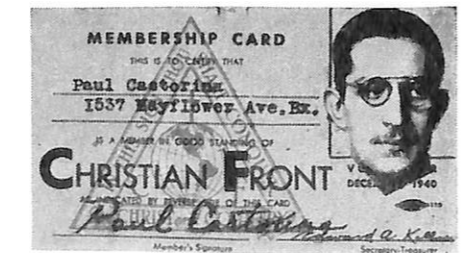

BOYCOTT ITEMS

U. S. Canary Raisers Keep "Getting the Bird"

LAST WEEK more than 2,500 canaries reached the United States from the Netherlands. This marks the first large-scale importation of our feathered friends from sources outside of Germany.

But the birds are Hartz Mountain stock, the breeders—just as you might suspect—coming originally from Germany.

U. S. canary raisers who are trying to take advantage of the boycott and blockade to develop the domestic canary industry, are finding it difficult meeting the unfair competition of foreign birds. The United States, incidentally, produces some of the finest canaries found anywhere in the world, equalling in vocal range and tonal production anything the European market has to offer.

Musical impresarios might also bear this in mind before importing foreign canaries.

Sudeten Germans No Longer 100% Nazi

SUDETEN GERMANS living in that part of Czechoslovakia first taken over by Nazi Germany rue the day they invited Hitler to march in. Although a few important Nazi leaders have been enriched, the large mass of Germans as well as Czechs are finding it increasingly difficult to support themselves or get any kind of jobs.

Because of the world boycott against Nazi goods, industries in the Sudeten area have suffered greatly. In addition, the War has resulted in even greater privations to a once prosperous and thriving industrial region under a democratic government.

When the Sudetenland became part of Germany, it became subject to the world boycott, and its industries received a severe setback.

"TERROR SPECIALISTS"

Individual Bundites, Fearing Suppression, Join Native Hate-Groups

GERMAN-AMERICAN Bundites frightened at the disfavor in which they are held by the American people, have developed a new technique for practicing their subversive activities. Individual members are infiltrating into "native hate-groups," such as the Ku Klux Klan.

Acting as "specialists in terror," who work in an advisory capacity, Bund members are in great demand. The scores of un-American organizations needing "experts" in their peculiar field are letting their hoods down when it comes to welcoming the Bundites and ex-Bundites.

Bund Discredited

The Nazis have come to feel that they can accomplish little through their own organization which has been completely discredited in the eyes of most Americans, and which they fear may soon be outlawed. They have, of course, long cooperated with such groups as the "Christian" Front, "Christian" Mobilizers, etc. It is by now well-known that Little Fuehrer Joe McWilliams has worked in the closest possible manner with the German-American Bund, a merger of his Mobilizers with the Bund almost having gone through—and still remaining a possibility.

But the new technique followed by Bund members is to join native groups completely as individuals, with no mention made publicly of their Nazi background. Thus, we find that several speakers—with strong German accents—at a Klan rally in New Jersey, addressed their audiences on true Americanism and Patriotism!

New Nazi Policy

There is every indication that the inception of the Bund technique followed a new policy laid down by higher-ups after l'affaire Kuhn. Realizing that as the war was intensified, American public opinion might swing even more heavily against the Nazis, the idea was to keep Bund members as effective "specialists", even if the Bund itself were ever to be disbanded.

The rape of Scandinavia last week, probably planned many months ago, appears to be having the effect which the Nazis feared. But with typical thoroughness, they had prepared for any eventuality, including even the outlawing of the German-American Bund!

COUGHLIN Versus CATHOLIC

"But, incidentally, I happen to be a priest in good standing and, therefore, feel that the entire attack levelled against me smacks not only of a personal nature but, possibly, of one against the Christian religion."

From a letter of Father Coughlin to his radio-listeners, dated March 20, 1940.

A list of names of prominent Catholic clerics and laymen who have either directly or indirectly "levelled" attacks against Father Coughlin would reach from New York to Royal Oak. Could Father Coughlin be referring to them when he talks of an attack "against the Christian religion?"

Eminent churchmen who have affirmed their faith in true Christian ideals include: The Rt. Rev. John A. Ryan, of the Catholic University, Washington; Archbishop Stritch, of Milwaukee; Archbishop Rummel, of New Orleans; Cardinal O'Connell, of Boston, and many more. Does Father Coughlin dare to intimate that these churchmen attacked the Christian religion when they attacked him?

Catholics Denounce Coughlin

The Committee of Catholics for Human Rights, including among many others, the Most Rev. Robert E. Lucey, Bishop of Amarillo, Texas; Rev. John P. Boland, Chairman, N. Y. State Labor Relations Board; Rev. Martin Carrabine, S. J., Moderator, Chicago Inter-Student Catholic Action; Sister Consuela, O. Carm., New Orleans, La.; Rev. Vincent C. Donovan, O. P.; Catholic Thought Association, N. Y.; Rev. Charles T. Carow, Brooklyn, N. Y.; Rev. Gerald Ellard, S. J., St. Mary's College, Kansas; Rev. Gregory Feige, New Jersey; Rev. Dr. Anselm Keefe; Rev. R. A. McGowan, N. C. W. C., Washington, D. C.; Rev. J. J. Tompkins, Nova Scotia, Canada; Rev. William J. Walsh, Philadelphia; Sister Mary Innocents, St. Mary Academy, Nardod, Ill.; Rev. James H. McConnell, Fredericksburg; and a host of other prominent churchmen and laymen, too numerous to mention, have joined in the denunciation of Father Coughlin. Were they attacking the Christian religion?

Twelve hours after the late Cardinal Mundelein, beloved Cardinal Archbishop of Chicago, had passed away last October, the Most Rev. Bernard J. Sheil, senior Auxiliary Bishop of Chicago, in a nationwide radio address, spoke as follows:

"I have felt that I would be unfaithful to the trust (the Cardinal) imposed in me if I failed to bear tonight the counsels of his practical wisdom and his spiritual tol-

erance which he wished me to say to his countrymen for him."

Explaining that he was making the address because it was one which Cardinal Mundelein "wished and authorized me to make tonight," Bishop Sheil lashed out at "emotional charlatans who have become statesmen overnight and whose unctuous voices betray a first urge to hear themselves no matter whose thought they convey.

"You know what—and whom—I mean," added the Bishop.

Bishop Condemns Intolerance

"Those who preach race hatred and intolerance among us in such a world at war are traitors to our lonely democracy.

"No man can be both honest and intelligent," said Bishop Sheil, "if he professes to want to safeguard peace in America at the same time he preaches the kind of racial hatred which has destroyed peace everywhere else in the world."

As the National Catholic Welfare Council stated:

"We regret and deplore the widespread propaganda in the interests of systems and theories antagonistic to the principles of democracy and the teachings of Christianity. A Christian people will oppose these dangerous aberrations with all the might of Christian charity."

" . . . I take my stand beside the Christian Fronters . . . I freely chose to be identified as a friend of the accused."
