

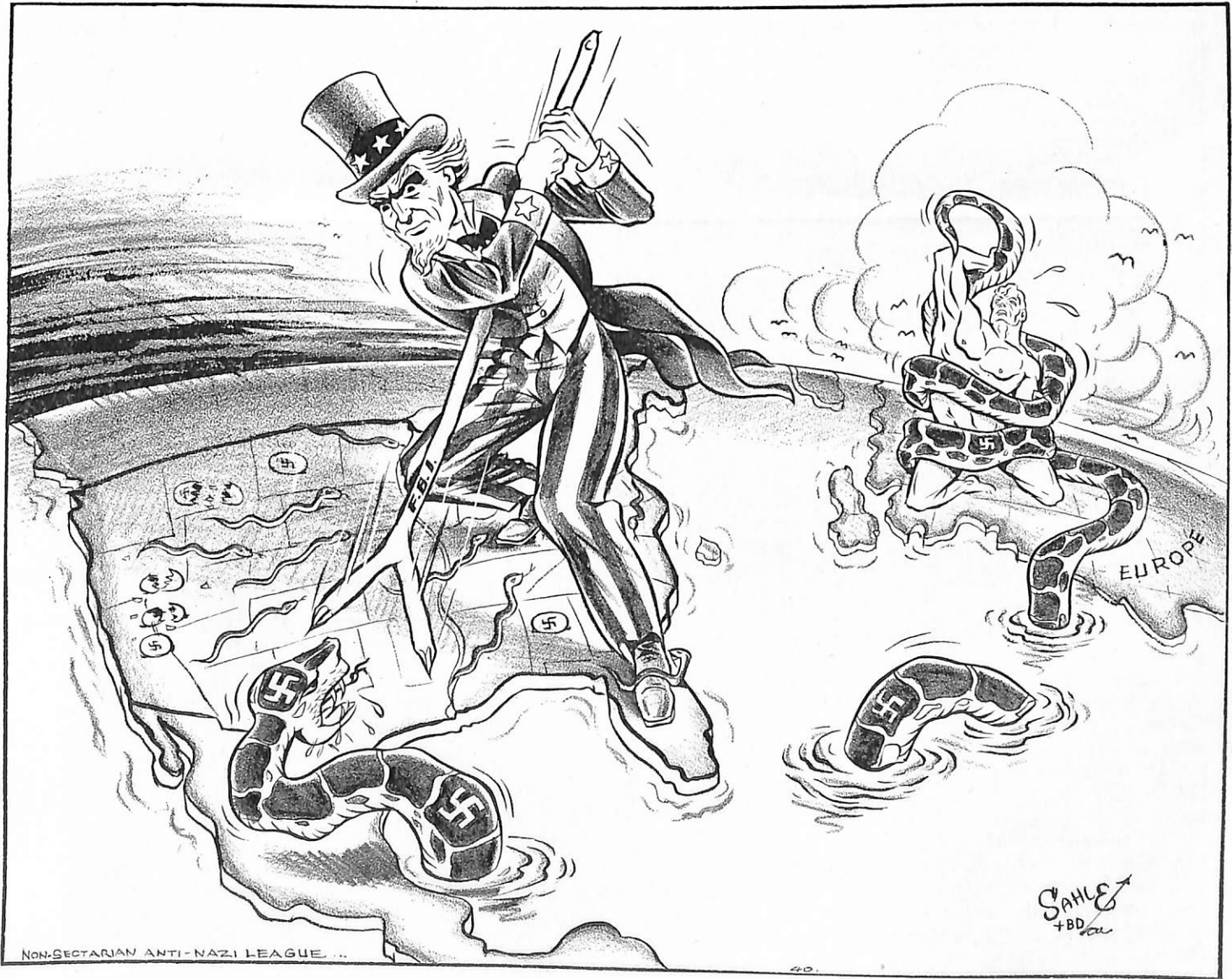

Germany's Financial Control of American Interests

Editor's Note: The following article, based on the most reliable sources, including the Federal Reserve Board Bulletins and the Reports of the Bureau of Foreign and Domestic Commerce, presents a factual outline of the terrifying extent of Nazi financial control in the United States. We present these findings of the League without dramatization, believing that the cold figures are sufficiently revealing in themselves.

IF THE slogan "Money talks!" is at all valid, Germany's language should be very effective indeed. For Germany is able to "speak" to American commercial and financial interests to the extent of almost four billion dollars. Directly or indirectly, Germany controls the fate of about \$800,000,000 of American money invested in the Reich and in various parts of the world which are either dominated or dictated to by the lords at Wilhelm-

financial influence in this country may reach the stupendous total of five billion dollars.

AMERICAN CORPORATIONS

The corporations represented by the direct investments include particularly the following (they are not presented in the order of importance nor are they arranged in accordance with the size of the relative stake):

Note: It is safe to assume that virtually all leading banks throughout the country hold balances for the account of the countries in question, their nationals, and corporations.

Germany's investments in the United States of the so-called direct type and portfolio type, together with cash balances, are placed at \$310,000,000. In addition, investments of the same category on the part of countries directly or indirectly dominated by Germany are placed at \$2,623,800,000. In other words, a total of well over \$2½ billion is, or may some day become, the property of Germany, or at any rate, an asset over which Germany will have considerable, if not complete, control.

Figures are presented in the box at the bottom of the page.

In connection with the investments referred to, it should be borne in mind that only where direct investments are involved or cash balances on deposit with various financial institutions will it be possible for the Reich to exercise a certain measure of control. To what extent this has already been done is difficult to state. A careful investigation would undoubtedly reveal some interesting information.

CORRECTIVE ACTION

Some corrective action must be immediately taken to prevent this potential Nazi control of American interests.

A simple and effective method might be for the government of the United States to block the investments of Germany here. Inasmuch as Nazi Germany does not allow American investors to take out any proceeds of their investments in that country, would it not be only fair if we blocked German holdings in the United States?

These funds might then be applied to the amount owed to American investors in Germany!

strasse. Details are presented in the subjoined table above.

The figures given above refer only to the so-called direct investments, that is, plants and properties in foreign countries owned or controlled by American capital. The word "controlled" is employed advisedly. Statistics do not include American portfolio investments, that is, bonds and other evidences of indebtedness resulting from the public or private sale of securities, nor do they include the so-called political debts of the various countries to the U. S. Government. American portfolio investments in the countries under review amount to substantially more than one billion dollars. On a substantial portion of this no interest is being paid, but it is not unreasonable to state that Germany, controlling the destinies of holders of such obligations, may be able to exert influence and pressure upon them. In other words, the extent of Germany's

Cross OR Swastika?

COMMUNISM, FASCISM and Nazism should be equally obnoxious to all Americans, because all of these isms are anti-democratic, all of them are inimical to Human Rights. But to some persons (permit me as a Catholic to confess that to the majority of my own faith), Communism is so much the worse of the evils, that they tolerate, if not actually lend aid and comfort to the Nazis and the Fascists.

Of the three isms—Communism, Fascism and Nazism — Communism came first. The Soviet Union was the first to establish a totalitarian order in which individual citizens are judged in accordance with their value to the state; they have no rights except what the state grants them, and their reading, their talking, their listening, even their thinking is determined, prescribed and supervised by the ruling clique which controls the state.

Mussolini, a former extreme Socialist, borrowed the Communist ideology and adapted it, under the name of Fascism, to the Italian People.

Hitler followed Mussolini, borrowed the same ideology and adapted it to Germany under the name of Nazism.

Each of them "improved," modernized and brought to a more brutal efficiency the same totalitarian idea of Communism. There is not one iota of difference in fundamental principles between the three editions of the same totalitarian ideology. And, of late, the leaders of the three totalitarian countries have given up their sham opposition to each other, and have openly joined forces to fight unitedly against all democracies.

How then can one explain the fact that some men, while justifiably opposed to Communism, condone Nazism, and help the equally damnable Nazi enemies of our country? How can one explain away giving aid and comfort to the Nazi enemies of our country on the flimsy excuse that it helps to fight Communism—Nazism's twin brother—while the Communists and Nazi-Fascists have made common cause? I know of but one explanation. While socially, politically and ideologically the three totalitarian States are alike, there is a slight difference in their attitude towards religion. The Soviet dictatorship is frankly Godless and Atheistic, and the others, while doing everything in their power to destroy the influence of the Church and to bring up the new generation under the complete control of the state, are still tolerating the Church and do not proscribe religious teachings.

This might have been true at the beginning but, even if one's reasoning is confined to the official German sources coupled with the meagre reports issued from the Vatican, one should know of the prohibition of Catholic Youth organizations, the confiscation of Church properties, the incarceration of priests, the indignities visited on nuns, the accusation of immorality brought against numerous priests, etc. Does that prove respect for the Church and for religion?

But the Communists are anti-Christian, you will say. True enough, and so are the Nazis, in spite of the fact that Hitler was born in the Catholic faith.

Here is the proof.

"The religions are all alike, no matter what they call themselves. They have no future—certainly none for the Germans. Fascism, if it likes, may come to terms with the Church. So shall I. Why not? That will not prevent me from tearing up Christianity root and branch, and annihilating it in Germany."

So said Adolf Hitler.

"Our leader becomes the intermediary between his people and the throne of God . . . Everything which our leader utters is religion in the highest sense, in its deepest and most hidden meaning."

So said Propaganda Minister Goebbels.

From a publication called "Watchman What of the Night?", published by such eminent Churchmen as The Very Rev. G. Ashton Oldham, D.D.; the Rev. Daniel A. Poling, D.D.; the Rev. Howard Chandler Robbins, D.D.; the Rev. George Stewart, D.D., we quote only two samples of Nazi irreligion, quoted by them, which for blasphemous and direct obscene character, we have yet to find an equal in any "literature" including the Communists'.

"The (following) quotation," write the authors of "Watchman What of the Night?", is an evidence that some of the attacks on the Church and its teaching have come from within the ranks of the clergy where some men, like the Pastor quoted, have assisted in the proscription of the Church to the purposes of the state. It should be remembered that many faithful pastors were replaced by men who were selected by Hitler's chosen Reichsbischof Mueller. The Bishop himself did not hesitate to rewrite the Sermon on the Mount to bring it into harmony with party teachings!"

NAZI CONSUL DRAEGER FIRST EXPOSED BY LEAGUE

Extra-Consular Activities of National Socialist Party Head Revealed to Public

REVELATIONS IN the press last month that Dr. Friedhelm Draeger, Nazi Consul in New York, is head man of the Nazi network of propaganda and espionage in the United States, culminated a series of previous disclosures by the Non-Sectarian Anti-Nazi League first released in June.

Long before the press or public realized the full extent of Nazi consular intrigue in this country, the Department of Investigation of the League had uncovered evidence which proved that Nazi officials here were carrying on subversive extra-consular activity against our country.

A letter which came into the possession of the League showed that Draeger had been the head of the "Ausland" organization of the National Socialist Party in the United States for many years. Other evidence indicated that he was the keyman between the Nazi Government and the Bund as well as native Fascist groups here.

On June 23 of this year, the League wired the State Department as follows:

"Appreciating your announced intention to investigate the activities of consuls stationed in the U. S., may we suggest that you include Friedhelm Draeger, German Consul in New York, who has taken advantage of his diplomatic immunity to direct anti-democratic propaganda here.

"The Non-Sectarian Anti-Nazi League has in its possession a letter written in German by Dr. Draeger, addressed to 'Fellow Party Members' in New York, in which they are ordered to attend a National Socialist Party meeting to be addressed by the 'political training-leader for the Berlin district.'

"This letter by Draeger identifies him as 'Consul and liaison-officer of the 'Ausland' organization of the National Socialist Party in New York'. The Ausland group, as you know, is the Nazi organization which controls the activities of every German outside of Germany.

"Dr. Draeger, furthermore, has been extremely active in the councils of the German-American Bund and was often principal speaker at Nazi conventions with Fritz Kuhn.

"Here in New York, hotbed of Nazi-directed subversive activity, an official such as the German Consul has been wreaking incalculable damage by aiding organizations like the 'Christian' Mobilizers and other subversive groups.

"At a recent meeting in New York, Mobilizer Chief Joseph E. McWilliams (running for Congress on a pro-Nazi platform) who has boasted of his connections with German officials, asserted that his storm troopers included the 'toughest bunch of ex-German Army-men to be found in Yorkville.'

"We respectfully request that you investigate the activities of the German consulate in New York and particularly those of Dr. Draeger."

Group Accuses Nazi Aide in N. Y.

NEW YORK, June 24—Asserting that documentary evidence in its possession showed conclusively that Dr. Friedhelm Dräger, of the German Consulate here, was carrying on National Socialist Party work, the Nonsectarian Anti-Nazi League had today addressed a telegram to Cordell Hull, Secretary of State, asking that he investigate Dr. Dräger's activities.

"The Nonsectarian Anti-Nazi League," the telegram said, "has in its possession a letter written in German by Dr. Dräger addressed to 'fellow party members' in New York, in which they are ordered to attend a National Socialist Party meeting to be addressed by the 'political training-leader for the Berlin district.' This letter is signed by Dräger as 'Consul and Liaison Officer of the Ausland, organization of the National Socialist Party in New York.' The Ausland group, as you know, is the Nazi organization which controls the activities of every German outside of Germany.

"Dr. Dräger, furthermore, has been extremely active in the councils of the German-American Bund and was often the principal speaker at Nazi conventions in New York with Fritz Kuhn."

This story from the Christian Science Monitor, dated June 24, shows how far back the League exposed Consul Draeger's subversive activities.

In reply, Assistant Secretary of State Adolf A. Berle, Jr., asked that the League "submit the document referred to in your telegram; likewise, any other documents which may bear upon the subject."

The State Department was at once sent a photostat of the Draeger letter together with other relevant information.

This letter was later referred to the Department of Justice for further investigation. During the summer, ramifications of the Nazi network in the United States were studied by the authorities.

Following the revelations by the League in June (an editorial and news story are shown in cuts) Draeger suddenly dropped out of the limelight. He curtailed his "social" activities, no longer attending meetings of the Board of Trade for German-American Commerce or the German-American Bund, and, in general, attempted to keep his name and activities away from the scrutiny of investigators.

Last month, the mass of accumulated evidence in the hands of government officials and the Dies Committee, provided to a large extent by the N. S. A. N. L., grew too weighty to be any longer disregarded. Draeger was shown to be the head of the secret United States division of the foreign section of the National Socialist Party. He was revealed to have been the "man behind the scenes" of the Bund, the American Fellowship Forum and other anti-American organizations.

Draeger still is all these things. Recent publicity may have made him sufficiently wary to be able to assert now that he is not carrying on subversive activity; but evidence in the hands of the proper authorities will prevent any but the most

credulous from believing his protestations of innocence.

Westrick and Ried have left the country. Draeger's turn comes next.

Other Nazi Consuls, like Wiedemann and Scholz, may soon discover that an aroused America will no longer tolerate their subversive intrigues against our institutions and our government carried on through virtue of their diplomatic immunity.

THE Non-Sectarian Anti-Nazi League has asked Secretary of State Cordell Hull to investigate the actions of Dr. Friedhelm Draeger, German Consul in New York City. The league claims to have documentary evidence that the consul is active in National Socialist party work and in bund activity in this country.

We believe that such investigation should be made. If the charges are true, Herr Draeger should be sent back to Germany as promptly as possible with no regard as to whether such

'Ausland' organization of the National Socialist party in New York." The "Ausland," meaning "foreign," is the Nazi organization that controls activity of Nazi Germans in foreign lands. It helps build the treacherous fifth columns such as those that betrayed Norway, Holland and Belgium.

The league charges against Dr. Draeger further assert that he has been active in the councils of the German-American Bund and has often been a principal speaker at Nazi conventions in New York along with Fritz Kuhn.

The United States Government should find out whether the consul is indulging in these or not. If not, his name should be cleared. If he is guilty, he should be removed from office. It is the duty of the United States Government to check up on other consulates to see whether they are indulging in similar activities. It is long past for them to be indulging in such activities. They know no other honor.

BUND NEWSPAPER PLAGIARIZES BULLETIN ARTICLE

Are the stooges of Hitler in the United States bereft of reason—out of their mind—or just plain crazy? Judge for yourself from the October 3rd issue of the Bund mouthpiece, the "Deutscher Weckruf and Beobachter".

In that issue the Bundsters reprint a letter which Sheriff Denton J. Quick, of Sussex County, New Jersey, is supposed to have sent to someone, in an effort to check on those who visited Bund-Camp Nordland.

Workers from munition factories in the neighborhood had been frequently observed visiting the Nazi camp. After the terrible Hercules explosion, investigations were carried on by several governmental departments, and the Sheriff, as was his duty, helped in the investigation. "Sheriff Quick and his co-conspirators parading and marauding after dark during the night on the highways, to deprive decent citizens of their lawful rights, in violation of the federal statutes against such unlawful night-raiding conspirators, is respectfully called to the attention of the United States Grand Jury and the United States District Attorney for the New Jersey District and to the F. B. I. for their action to stamp out un-American activities, instituted, inspired and carried on by this great anti-Christian Crusade, which in collaboration with Leo Spangler of the Anti-Nazi League to Champion Human Rights, Inc., (of which Congressman Samuel Dickstein is the reputed head), (sic) and Joseph Tennenbaum, head of the Jewish Boycott Bund, continues its illegal boycott to strangle all German American life and dry up the blood flowing in German American bodies."

I have heard many maniacs rave while in a state of delirium, but I admit that the above two paragraphs about foreign uniforms and the drying up of "the blood flowing in German-American bodies" can not be equalled in any recorded hallucination.

Even the other statement in the Weckruf article that "this quartet of hat-mongers continue to institute, stimulate

and maintain their anti-Semitic campaign for the sole purpose of continuing domestic discord and insurrection among the classes and races that go to make up our American citizenry", can not equal the ravings quoted above.

But this is not all. The Bundsters have also plagiarized two articles published in the last issue of the Anti-Nazi BULLETIN and used them as their own!

Nazi Fifth Column In U. S. Already In Existence

IV.

NATIVE LEADERS OF THE NAZI FIFTH COLUMN

GEORGE DEATHERAGE:

Before he became a Fascist, he was an engineer. When Hitler became the ruler of Germany, with the help of his brown-shirted private army, Deatherage formed his private membership organization, known as the "Knights of the White Camelia."

At first, this organization was supposed to be devoted to the preservation of Constitutional Government, but, in 1937, Deatherage made an unsuccessful attempt to unite all other Fascist groups into an American Nationalist Confederation. Seventy-two organizations were represented at the Kansas City, Mo., convention, held August 20th, 1937. Deatherage did not succeed in becoming the supreme Fuehrer of all these organizations but he appointed himself leader of the Confederation anyhow.

In the April 9th issue of his "News Bulletin" he announced: "The time has arrived for a practical and constructive plan of government to be offered to the nation. None other is strong enough to save the nation from complete destruction at the hands of the international control," and two weeks later, his publication was decorated with the Nazi Swastika and its editorial began, "This issue carries at the masthead our newly selected emblem, the Swastika."

Since then, Deatherage has been distributing large quantities of Nazi propaganda issued by the World Service Conference in Germany where he delivered an address which was published in the World Service Bulletin and sent throughout the entire English speaking world. He makes no secret of his Fascist movement nor of his advocacy of the use of violence.

To Roy Tozier, Research Director for the Friends of Democracy, he once said, "I wonder if you liberals have the guts to die for what you believe. If I were the boss, the best you could hope for is a concentration camp. But probably it will be necessary to kill most of you." There is in preparation a catalogue of the nation's leading liberals, said Deatherage. Franco in Spain had the names of a million internal enemies. The American catalogue will be larger. The importance of this statement may be seen from the following item printed in the New York Times on March 16th:

"Refugees from the Netherlands, from Queen Wilhelmina down, have told amazing stories of the manner in which thousands of apparently innocent Germans turned out to be advance agents of the Nazi regime. The German parachutists landed with lists of addresses of sympathizers in their pockets. Not only were the Germans living in the Netherlands prepared to receive the German parachutists, but many Netherlands traitors were uncovered as well, despite the fact that the avowed Netherlands Nazis were estimated to number only 120,000. One refugee remarked that it almost seemed that there were more Germans than Netherlands in The Hague."

And yet, when Deatherage appeared before the Dies Committee on May 23rd, 1939, and refused to give any information on the plea that his organization imposes a secret oath on its members, nothing was done about it. He is not even registered with the State Department among the agents representing or working for a foreign Government.

That roar in your ears, ladies and gentlemen, is the satanic laughter of the denizens of Hades at our democracy for pro-

tecting such enemies and permitting such termites to undermine the very foundation of our existence.

GEORGE CHRISTIANS:

George Christians is evidently convinced that he is destined to become the American Hitler. He even trains a lock of his hair to fall across his forehead. He hasn't yet reached the stage of the Charlie Chaplin mustache.

He is an engineer by profession and a Fascist by choice. In 1931, after reading about Mussolini's Corporate State, George Christians formed a membership corporation (of which, naturally, he assigned himself to the position of leader), and called it "Crusader White Shirts." The organization he dedicated to changing the United States into a modified Corporate State, by means of violent revolution.

At that time, during the depth of our economic crisis, many were discouraged and dissatisfied with our system which permits "wholesale unemployment and insecurity amidst plenty." George Christians capitalized the depression and organized chapters of his crusaders all over the country.

To his followers Christians sent some of the most inflammatory pamphlets and leaflets ever to come from an American Fascist organization. Here is a sample of one of his "general orders":

"No unit of the Crusader White Shirts should attempt any positive action until it has been thoroughly drilled and officered and perfect discipline has been obtained, nor should it attempt to move until it is sufficiently strong to accomplish its purpose without any chance of failure. The first objective should be to take control of the local government . . . Preparation should then be made at once for the Crusade to Washington . . . As soon as you are fully equipped and prepared to go to Washington, report to the Commander-in-Chief . . . stating the number of men, how equipped and time required to reach Washington, but do not move until ordered. Nothing must fail . . . Read these orders very carefully. Strike hard, straight and swiftly. Get what you start out to get."

Christians admits frankly that he has no personal feeling regarding Jews. However, he is willing to employ the propaganda device of anti-Semitism in order to achieve his ends. The masses, he says, are so constituted that they can be swayed only by giving them a leader to follow and a group to hate.

Here you have the Hitler credo in a nutshell—anti-Semitism as an entering wedge, as a means to achieve his Nazi ends. And George Christians, too, is permitted to continue his propaganda under the protection of our liberal laws.

To be tolerant is a virtue, but to be tolerant of your enemy who declares his intention to destroy you and to protect his liberty and right to prepare himself for your destruction, stops being a virtue. It borders on criminal negligence not to protect your own interests.

ARE HITLER STOOGES *Insane?*

Justice Edgar Bromberger is to be congratulated on the progressive step he has taken in testing the sanity of the Hitler stooges who were arrested for disorderly conduct.

Unfortunately, the legal definition of insanity is quite different from the medical conception of mental aberrations. Legally, one is not insane unless one is a blubbery idiot. Therefore, people who suffer from hopeless and incurable cases of paranoia must still be declared legally sane.

In the two cases which Judge Bromberger referred to the Psychopathic Division of Bellevue, William Fox was declared a psychopathic personality but legally sane. Translated into ordinary language, it means, medically unbalanced, legally not. Joseph E. McWilliams was declared legally sane and responsible for his acts, but, every medical student, knowing the rudiments of psychiatry, would recognize in these men as well as in their co-leaders symptoms of paranoia of the worst sort.

According to the Medical Dictionary, "Paranoia" is a form of insanity, marked by systematic delusions and is chronic in its course. A "delusion," according to the Medical Dictionary, is a mistaken conviction of the falsity of which not even the evidence of the senses will convince the patient. One suffering from "expansive delusions," is a person who has an insane belief in his own greatness, goodness or power; and, "systematized delusions" are delusions carried out by the patient in a logical manner.

JOE'S RECORD

Now, in view of these definitions, let us look at the record of Joe McNazi. He is an uneducated young man, possessing the "gift of gab," having drifted from one thing to another, unable to settle down to anything he tried. The example of Hitler coming to power, a man who rose from the ranks of nonentities to become the supreme ruler of Germany, fired McNazi with the inspiration that he too might become as great as Hitler, and since then this became his all consuming, overpowering ambition.

We have in our possession an affidavit by one of his co-workers who helped organize his "Christian" movement and in this affidavit it is stated that McNazi copied the original Hitler Beer Putsch organization, promising to make each one of his co-workers ruler of a separate department of the United States whenever he will get the ruling power in America.

In a statement to a reporter for the *New Yorker*, as published in that magazine August 24th, 1940, McNazi said: Adolph Hitler is the greatest leader in the history of the world.

America suffers from effeminacy; it is time to get strong. I intend to get a huge following and run the government like a factory, appointing all the key men. I may not be president but I will have ABSOLUTE CONTROL.

The Jews are in control and demand complete intellectual subservency. To combat this, I would ship all the Jews to some place as Madagascar.

As far as violence is concerned in my methods, I will only say that I MUST HAVE CONTROL.

I look on every newspaperman as a prostitute. I have a blacklist of the worst ones and THEY WILL BE TAKEN CARE OF. The newspapers and magazines will be run with a firm hand. We'll make a REAL free press.

Once in power, I will down all dissident opinion.

To the writer of this article, himself a physician, these are definite symptoms of expansive delusions and paranoia.

In our opinion, it is insufficient to sentence such Hitler stooges to thirty or sixty days in prison on a charge of disorderly conduct. What we should do is to have them all examined by a Board of Medical experts and confine them in an institution for the mentally sick until competent medical authorities testify to their recovery. I am sure that I betray no secret by revealing that the chief leaders of the totalitarian countries suffer from a form

of insanity, in some cases, which follows neurologic involvement of a syphilitic infection. If they were sent betimes to an institution for the treatment of their ailments and watched for the tertiary manifestations of this malady, the world might have been saved the horror, bloodshed and the sacrifices of the present War.

We, in America, still have time to take steps in the right direction and isolate and treat such Hitler stooges for what they are—mentally sick, demented, paranoiacs, potentially dangerous to society.

Paranoiacs, suffering from delusions of grandeur, can become a menace to society, as proven by the bitter experience of other countries.

In all sincerity, we suggest to our Department of Justice that as a measure of defense against internal enemies, a commission of nationally prominent psychiatrists be appointed to examine the Hitler stooges in our country as to their sanity, and to confine them to hospitals before these raving maniacs may wreak irreparable damage to our country as their brother maniacs have done in the European countries.

It was organized by evidence that its view is internationalistic and not nationalistic. Moreover, no one in the United States has the right to operate a detective service. The league is doing. This intelligence service is not to protect the American people, but it is engaged in the destruction and subversion of our own Government. I hope the Intelligence Department will now take up and conduct such investigations for which the
