
## sen. Coudert Haar roof of Fascists in Schools But Ignored It

State Senator Frederic R. Coudert's own files on the New York public schools show that he whitewashed Italian fascist propaganda.

Active evidence of Italian Government propaganda in the schools of our city was before Senator Coudert when he published the report of his state legislative committee, which said last week:

"It (the committee) has found no substantial evidence tending to show the existence of a Nazi or Fascist conspiracy."


## SUPPRESSES EVIDENCE

Coudert suppressed this evidence against Mussolini for the same reason that he suppressed the evidence of Christian Front propaganda in the school system against the Jewish people and America's military allies, which we reported last week.

Coudert's firm as we showed at that time, is the attorney for the Vichy Government of Laval and Petain, which takes orders from Hitler and works with Mussolini.

He is also the spokesman for some of the worst reactionaries in America.
