Our Greatest Danger --- a "Bemused" Public

Although the continuous deluge of new deal propaganda has backfired in many instances, it has succeeded in confusing innumerable minds. A fair understanding of the intricacies of European political conditions would require a long course of study on the part of an intelligent American, and the average citizen is woefully ignorant of the facts. On one side practically all of the truth has been suppressed; on the other the facts have been distorted and much lying propaganda has falsified the issues. Public bewilderment and distrust of old standards are assets of radicalism, a necessary factor of planned mental "conditioning" for war.

The cost of the newspaper control is beyond estimate; it has been in process of development for many years. Administration propaganda is a mere supplement, but its cost runs high. On the 9th, Representative Rich told the House that "hundreds and hundreds of thousands of dollars of taxpayers' money" had been voted for new deal propaganda. Representative Thomas declared, "I think a better estimate would be \$100,000,000 a year. . . There is one item of \$30,000,000 alone which has to do with the cost of paper consumed in various kinds of pamphlets, periodicals, newspaper releases and so on. So the gentleman will certainly be able to figure out that it costs \$100,000,000 a year."

Although the people are waking up to the perils of war and the danger of radicalism, the power of propaganda to mislead and destroy is basic in the new deal scheme. The condition demands immediate organization and honest leadership. The public distrust of the administration and its increasing realization of the Jewish peril invite false leadership. In Europe similar public confusion has been taken advantage of again and again, and undoubtedly some prominent Gentile "front" is being groomed as this country's false savior. We are confident that a trustworthy appeal would meet with instant and overwhelming response. The U.S. is hearing the last call for a leadership that cannot be bought nor deceived.

Who Now Wants Peace?

At the close of last week, G. Bernard Shaw's declaration that "the war is over" covered a multitude of indications. Lloyd George, also, has strongly suggested peace, with H. G. Wells joining in the chorus. For many years, these men have been tools and mouthpieces of international Jewry. More significant is the fact that Mosley, leader of the British Union, has been holding successful peace meetings in London, and that the fact has been allowed to leak through the English censorship and the American Jewish control. And that international Jewry now wants peace for the time being is still further indicated.

During the World War, Germany, France and England were under Jewish control, and an "understanding" prevented the bombing of Jewish-owned mines and munitions factories in those countries. It is supposed that much other Jewish property was protected. Poland had the highest Jewish population in Europe and was dominated by Jewry. The Polish new deal had developed over a number of years, and it is estimated that at

least 85 percent of all properties in Poland were owned by Jews. Most of the farm lands were in hock, and through manipulation of Jewish middlemen, returns from the land hardly paid the interest on the mortgages. A great deal of Poland had been taken over, and the loss of Jewish property appears to be a very high price to pay for the relatively moderate Christian slaughter.

Now, in Germany, comparatively little property is owned by Jews, while in France and England a very large amount of real estate is in Jewish hands. Also, there is no doubt that the German air force has spotted all of the estates of wealthy Jews who have bought British titles. Because of the superior German air force, English and French Jews stand to lose tremendously if the war is allowed to pass into an active stage. Hence the prominent "fronts" demand peace for their masters. It may be a devious scheme to further "bemuse" the Gentiles; but it looks as if world Jewry wants a breathing spell.

Chamberlain Trades Umbrella for Gas Mask

If there was not a backstage understanding that Chamberlain's defiant reply to Hitler on the 12th would be followed soon with a more pacific statement, there may be an attack on the British fleet before this report reaches you. If it comes, it will be just a sample of what is to follow if the war runs its course. To informed minds, the tone of Chamberlain's speech, with its emphasis on "honor" and acts of aggression, recalls the latest of many hypocritical acts. England's double-crossing of the Arabs and breach of faith with the Jews, with the slaughter of hundreds of the former and the bombing of Arab villages, is an example of the putrid standards of European statesmanship.

If Chamberlain has touched off the fuse, present indications are for a month or so of severe Anglo-German fighting, then a pause for peace negotiations. Russia's advent has upset many applecarts, and this week's activities of the USSR indicate careful planning and uncanny foresight. Turkey's part in the outcome will be of vital importance. It is reliably reported that England has sent four soldiers to India to every one sent to France. It is too early to predict with assurance the realignment in Europe; but it will begin to develop soon and will show up the falsity of all present and past propaganda. Also it will reveal stranger bedfellows than Stalin and Hitler.

Embargo Sabotage and Jewtrality

Administration officials say they are absolutely confident that the embargo sabotage bill will pass within the next two weeks. Both Jewry and the administration have placed all possible power behind the measure. However, many proponents are secretly wavering, insiders say, because of the mail from their constituents. Business reporters have taken passage of the bill for granted, as have all of the swarm of

The fight has served to awaken the country to the war peril and to enlighten many members of Congress. There will be an effort to keep Congress in session, and it should be supported by the public. On the 11th, Senator Burke (Neb.) outlined the administration's attitude. In a long speech he declared, "Our sympathies, our moral support, our material help within the restrictions imposed, everything that we can do short of supplying men and money, should be done on the side of the Allies as the most helpful means of bringing an early termination of the war with a just and lasting peace".

The same day, in a brief but hot debate in the House, Representative Thorkelson said: "I want to say that the U.S. Government has no right to send our officers to Great Britain to arrange plans for aid or help to Great Britain, particularly at this time, because Great Britain is now at war. In doing that, it is equal to a declaration of war. It is a causus belli as far as the German Government is concerned. The

President or any administration performing an act of that sort is liable, if Congress so decides, to meet a charge of treason. . " (See "Must" Reading List---this issue)

Several members of Congress are considering the proposition of demanding an investigation as to why our fleet was ordered to the Pacific, and if it was according to a secret arrangement with England. There is a growing conviction that an agreement has been made for this country to protect all British interests in the Far East.

Another Key in Industrial Control

Wage Hour Division, Labor Department, was set up as an independent agency in most administrative matters. With the exception of top executives, the personnel is handled independently of the Department and through the division's offices. The 1940 appropriation was set up in a manner that does not seem to conform with the law, and the division is being nicely streamlined.

Administrator E. F. Andrews is being replaced by Col. Philip B. Fleming, ace new-deal trouble shooter and active Army officer, insiders say. Andrews has not been officially informed of the change. The Department is keeping the matter quiet, although Fleming is active in the division. The appointment was made by the Secretary of Labor without consultation of labor leaders, and is subject to congressional confirmation. Authorities say that Roosevelt does not want Congress to know of the appointment, because of probable objection to an Army officer in the job. When labor leaders hear of the appointment, an explosion is anticipated. We understand that the plan is to allow Fleming to run the division without official appointment, and that after adjournment Roosevelt will make the appointment subject to later confirmation.

The Wage Hour Division's program will set up not only wage standards and rates, and hours, but also working conditions, apprenticeship standards, rules and regulations. Apparently, it has access to the books and employment records of employers, and authority to order any action it deems desirable when based on the records. It has taken over many of the functions previously handled by unions and employers, and is obviously designed to pass under the Industrial Economic Agency as the key-control of labor and working conditions. In this division is incorporated all of the features that are objectionable to employers and labor in the NLRB.

Economic Control and Advice

Announcement of the Industrial Economic Agency is scheduled for announcement by the Department of Commerce soon. If a successor to Knudson has been selected his name is a dark secret. . The Joint Advisory Board has not been disbanded. It has been scattered so that it will not attract attention. This action was taken because of pressure from the press and Congress which threatened to force the asking of questions by a special committee. Meetings of the Board are held regularly in Washington, according to insiders.

ACLU to Save Communism

Meetings of the American Civil Liberties Union, red front organization, last night and today in New York, are said to be the result of hysterical spy agitation started by the Department of Justice. Warren Madden (NLRB) and other star new-dealers are on the speakers' list, while J. Warren Elbert Thomas, the conference is headed by William Allen White, Col. William J. Donovan and Mary E. Wooley. A. Cloyd Gill, of New York, has written:

"This conference is a smokescreen for launching a fight to prevent the outlawing of the Communist Party and other subversive groups. The meeting, with its various panels, is a real and immediate menace. Every patriotic group should enact strong,

enlightening resolutions exposing the scheme, and give them widest circulation. . . The family quarrel, started here between the Stalinist communists and socialistic groups of several hues, is nothing more than one clique of reds trying to oust another group of reds. One is as bad as the other. Many misinformed people believe the American Labor Party and Labor's Non-partisan League will become American, once the communists are out. The 'anti-communist' gang is dominated by Labor Party officers who were born in Russia and Poland."

What Has Happened to Communism?

Back in 1933 we published the fact that many communists had been placed in new deal organizations. For making this and similar statements we were threatened with prosecution and arrest. In 1934 we published the red records of 24 Roosevelt appointees to high places, showing them to be "fellow travelers". Two were and still are in the Cabinet. Russia, recognized over the protests of organizations with 40,000,000 members, was under the domination of a central committee composed of 56 Jews and three Gentiles. Both Russia and the administration were under the control of Judaism which still controls the new deal.

Until recently, communism was given free rein in this country. Army and Navy intelligence divisions were instructed not to give out any information regarding red activities. Police red squads were disbanded in many cities on orders from the administration. Thousands of OGPU secret agents, who had come to this country after Russian recognition, were given aid and comfort. Every encouragement was given to the promoters of communism, and its alien agents were protected from deportation.

The Hitler-Stalin agreement confirmed many strong rumors and reports to the effect that Russia, widely advertised as a communist paradise, had broken the control of Judaism. Almost immediately, the Dies un-American Committee began investigating communism. During recent weeks a number of witnesses, mostly Jews, have appeared before the committee to damn communism and communists. This week, "General" W. G. Krivitsky (Ginsberg), a former OGPU agent, was a star witness. Obviously, the new propaganda scheme is to create the false belief that communism is not Jewish.

Save the Embargo

On the 12th, Representative Hoffman told the House, "We all know that the President is preparing for war, whatever his intentions are for putting us into it. We all know that the plan for a draft---a skeleton plan at least---has been outlined. We all know that plans for the mobilization of industry and war resources have been drawn." If you do not want war, write your Representative to vote against the "Sol Bloom-Barney Baruch credit-and-carry war-promotion bill."
