Dear Harold:

I am returning herewith the material you sent me about your Freedom of Information Act case. I found it very interesting.

I met with Mr. Better yesterday for two hours to discuss your case, primarily the proof of damages. We also generally discussed settlement prospects. I mentioned that our rock bottom figure was \$18,000 net to you.

He stated this his authority to settle was limited to \$10,000 and anything over that would have to be approved by the Justice Department. He stated that he doubted the Justice Department would approve a settlement over \$10,000 but he was waiting for a definite answer either Friday or next week.

Assuming that we cannot settle the case, I plan on devoting almost full time to preparing for the case commencing the first week in January. I hope that both you and your wife will be available. I will be in touch with you about contacting witnesses and setting up schedules for preparation for trial.
