REQUEST OPIM AUTHORIZATION TURN ALVARADO OVER TO [] WITH BRIEF EXPLANATION HE CLAIMS TO BE WITNESS TO PAYOFF TO OSWALD IN CUBAN CONSULATE 18 SEPTEMBER, ADMITS IS IN MEXICO ILLEGALLY, ADMITS CP MEMBERSHIP, ADMITS VISITS TO SOVEMB, CLAIMS THAT CUBAN CONSULATE NOW INVOLVED IN DOCUMENTING HIM WITH FALSE MEXICAN PAPERS FOR TRAVEL TO CUBA. LATTER POINT ALONE WOULD GIVE MEXICAN AUTHORITIES GOOD REASON TO SUBJECT HIM TO DETAILED INTERROGATION.

2. WITH HQS APPROVAL OF TURN-OVER STATION WOULD PLAN NO FURTHER CONTACT WITH ALVARADO.
