1. [LIEMPT]:

[LIEMPT]: To provide full daily coverage until further notice of All Club activities... providing special reporting on any unusual activities and all movements and activities KOS and ALF. Defective camera has been received by GERT...

[LIMITED]: To dispatch team on KOS commencing radio watch at 1400. Team contacted base at 1430 and base noted KOS not at Club at that time. Will also attempt cover by special rpt any unusual activity of Club or its personnel.

[LIEMPT]: Ordered to full day's coverage... approximately 1400 this date... this until further notice. Will provide special reporting all unusual activities all club members and special reporting on activities and movements KOS and ALF.

[LIEMPT]: To obtain all data from base as of today, provide all logs and process... provide all phases... all bases. Make contact with [LIMITED] and arrange this case... operator to dispatch [LIEMPT] team on KOS. Also to contact name of [SCANTLING] and get [LIMITED J-144] from S's wife (as S out of town). If necessary have wife notify S to return to Mexico and provide this [J-144] if she does not have access to it. G to try keep in reg telephone contact with undersigned, every hour if possible... and as often as possible if hourly not possible.

2. [LIEMPT]:

Team to contact [LIMITED] and to stay on KOS as long as possible and close as possible consist of with security. To be especially aware other, possible official, surveillance KOS or other Sovs of the Embassy. [L-3] (team leader) to be in phone contact with CO every two hours.

3. [LIEMPT]:

[LIEMPT] instructed to provide all data from [74 KUZ] on up to Gate basis... special pickups to be arranged as necessary. Will also try to provide coverage of [15-86-46] (no name of G. Kozov, Kazensev, and Baskin) commencing today.

4. [Karen C. UTYLOCKI]

To act as "message centre" and relay for any and all calls for undersigned from above assets. She will be kept to undersigned's location and where calls should be relayed...
