Reason for Board Action: The text is redacted because it discusses sources and methods that properly may be withheld under Section 6(1)(B) of the JFK Act.

Substitute Language: None: The redacted information contains no substantive information about the assassination of President Kennedy or about Lee Harvey Oswald.

Postponement # 3 (Page 3):

Reason for Board Action: The text is redacted because it discusses sources and methods that properly may be withheld under Section 6(1)(B) of the JFK Act.

Substitute Language: None: The redacted information references "the 1 October intercept on Lee Oswald" and the possible existence of another copy of that "intercept" that was discovered after the assassination. The redacted information contains no other substantive information about the assassination of President Kennedy or about Lee Harvey Oswald.
