Such abuse was neither surprising nor disturbing to Oakland-born Warren Olney III. As , chief counsel for Governor Warren's Commission on Organized Crime, he had poked an inquiring thumb into the steaming pie of California's underworld and had come up with some juicy plums: Howser, he claimed, had done little to rid the State of slot machine, punchboard and bookmaking rackets; and, in fact, the aroma of a State-wide

protection system could be traced, he said, right to the Attorney General's office.
