12/1/69 to A- long time since I asked about access to JFK shirt, tie. Told couldn't be shown. Asked about pix. No word since. Asks: closeup shirt to clearly show slits and front, side views tie nick, 8x10 CE 394,5. Close to original as possible and not with screen-print of photo only.

1/27/70-to A: Photos without meaning, do not show what was testified to. By saying will not provide spec. pix and supplying what shows nothing, are you not seeing to it that no one can have meaningful access to this basic evidence. Have lab make enlargements as clear as possible showing slits. Also do this with tie. Want to see other photos clothing.

3/13/70 Again asks enlargements because what sent meaningless as evidence

3/16 Will write after seeing enlargements and will arrange see their pix, but if already made, why no copies

3/19 r'c'd worthless enlargements, showing gore only, not slits. If they can't supply from what they have, why can't they make pix for me? Suggest danger conspiratorial interpretation. Ask aren't they suppress evidence?
