As a matter of fact, a few choice selections from this report on the FBI and CIA withholding with the CIA on p. 6 from the CIA's own review - might be good to have on hand.

This has been a much-interrupted day so maybe my head needs an extra twist to be and to write straight. I think you want to be prepared on Thursday to make an assault on good-faith. You can do this without involving yourself by telling the judge that I had addressed this to you in the drafts of several long and factual affidavits you have not had time to do anything about. Have the sixth-circuit letter with you, or copies to hand around like Hamsel's special cards. I'd be prepared to go into the transparent non-compliance bracketing it with the abuse of Green and us, and the best examples, I think, are the totality of FBI withholding, citing the new accounts; and the totality of not even a statement of compliance from any Division of the Dept. Sure the Colber stuff is useful. I'd note no response on the "confession" under other suspects but keep it mysterious. It will be a bombshell, so save the fireworks for the real day of celebration. However time answers short of falsehood we have a winner, so I think you may want to include that. What I'm suggesting is the simple, the comprehensible that relates to the current issue, compliance, but in every case has overtones of intent and motive.

Do you want to consider what we have always avoided, something dramatic? I have the FBI reports and other records showing the FBI got the Milibar tape. Use that transcript-read it- and ask why it has not been delivered under this Complaint. My typescript is filed away. Had was one. But I'd use the book, which is got in type from my copy, which is why it is filed away. I'll try to remember to have the rest of CD 1347 that we get under FOIA- and that you had to use that to get it has relevance - with me. If you have a copy, suggest you have yours. Let Duggan heller.
