There are more file numbers. He has a list of five that I spotted in examining the first batch. I found at least one other one later.

There are other files. One is Inv, which I took to mean investigative or investigation. There are also other files kept in the offices. Several have handwritten notations like "for my Ray file."

In addition, none of the records provided to now contains any reference to any re-investigation. These have to have generated other files that are relevant.
