DISCUSSING ACTIVITIES OF HER DAUGHTER, [REDACTED] SHE STATED SHE WAS UNWARE AS TO THE EXTENT [REDACTED] WAS INVOLVED WITH INDIVIDUALS INVOLVED IN BOMBING MATTERS. SHE DESCRIBED HER DAUGHTER AS THE BEST [REDACTED] IN THE UNITED STATES.

PRIOR INTERVIEWS WITH [REDACTED] SON AND DAUGHTER IN LAW INDICATE THAT [REDACTED] HAS A MENTAL PROBLEM, BUT NO INFORMATION DEVELOPED THAT SHE HAS BEEN IN A MENTAL INSTITUTION.

IT IS NOTED THAT THE VARIOUS INDIVIDUALS IDENTIFIED BY [REDACTED] WHEN CONTACTING INFORMANT, HAVE EXTENSIVE HATE TYPE BACKGROUNDS AND CAPABLE OF SERIOUS ACTS OF VIOLENCE.

MIAMI HAS NO REASON TO <sup>4</sup>QUESTION THE INFORMATION FURNISHED BY INFORMANT, AS HE OBTAINED IT FROM [REDACTED] ALTHOUGH INFORMANT IS NOT BEING UTILIZED BY MIAMI, NO INFORMATION HAS EVER BEEN RECEIVED FROM HIM WHICH WOULD INDICATE THAT HE IS FURNISHING FALSE INFORMATION.

IT IS, THEREFORE, BEING LEFT TO THE DISCRETION OF THE OFFICE OF ORIGIN, WHETHER THE INFORMATION RELATIVE TO [REDACTED] [REDACTED] WARRANTS ADDITIONAL INVESTIGATION BY THE MEMPHIS AND JACKSON OFFICES.
