- 2/11/76 Defendant's motion for protective order, denied.
Defendant to answer interrogatories w/in 10 days
- 4/12/76 Filed 4/9/76 granting defendant's motion for enlargement of time in which defendant may file opposition to plaintiff's motion to compel to & including 4/21/76
- 4/22/76 Stipulation extending time defendant may file opposition to motion of plaintiff to compel to and including 4-22-76, approved
- 5/18/76 Court directs defendant to respond to requests of plaintiffs by 6/2/76
- 8/12/77 Defendant to file response to motion under Vaughn v. Rosen by 8/19/77
- 8/12/77 Stipulation that processing of the FBI Memphis Field office files pertaining to "The Invaders," the Sanitation Workers Strike, James Earl Ray, and the MURKIN file is undertaken immediately by defendant and will be completed by 10/1/77, approved.
- 8/15/77 Stipulation directing the FBI to process certain files immediately by defendant, and directing this should be done by 10/1/77
- 9/2/77 Order filed 8/31/77 denying motion of plaintiff for consideration under Vaughn v. Rosen
- 9/30/77 Stipulation extending time plaintiff shall have to oppose defendant's motion for partial summary judgment w/respect to the Joseph Louis photographs to & including 10/12/77, approved.

- 11/21/77 Stipulation extending time which defendants may file an opposition to plaintiff's motion for waiver of all search fees and copying costs to & including 11/30/77, approved.
- 12/14/77 Stipulation extending time for defendants to file a response to plaintiff's motion for waiver of fees, to & including 12/19/77, approved.
- 2/13/78 Opinion filed 2/9/78
- 2/13/78 Order filed 2/9/78 granting plaintiff's motion for summary judgement regarding the application of the Freedom of Information Act and denies defendant's motion for summary judgement.
- 3/6/78 Opinion and Order filed 3/3/78 directing U.S. Department of Justice to file with the Court within 8 days of 3-2-78 an explanation of how search and copying charges were assessed ar. (signed 3/2/78)
- 5/10/78 Court directs counsel for government to submit letter to counsel for plaintiff and the Court by 5/12/78.
- 5/22/78 Order filed 5/19/78 extending time for transmission of the record on appeal to & including 7/9/78.
- 5/24/78 Plaintiff to file requests for admissions promptly
- 6/26/78 Court directs defendant to answer plaintiff's motion for Vaughn v. Rosen in 30 days.

- 10/31/78 Order filed 10/27/78 denying motion of defendants to strike.
- 6/21/79 Stipulation extending time for defendants to and including 7/3/79 to respond to plaintiff's motions for partial summary judgement.
- 7/9/79 Order filed 7/6/79 that the Court will defer its ruling on motion for an order requiring defendant to pay fee for work plaintiff has performed pending disposition of the case.
- 7/9/79 Order filed 7/6/79 of plaintiff for a protective order denied in part; granting in part motion of defendant for a protective order.
- 8/6/79 Order filed 8/3/79 granting defendant's motion for a protective order and directing that no depositions shall be taken in litigation and that no discovery whatsoever shall be taken absent further order of the Court.
- 8/15/79 Order filed 8/13/79 that the Court will defer its ruling on the motion of plaintiff for summary judgement pending disposition of the case.
- 8/16/79 Order filed 8/15/79 denying plaintiff's motion to reconsider and vacate this Court's order of 7/6/79.
- 8/16/79 Order filed 8/15/79 granting plaintiff's motion for partial summary judgement.

Order filed 8/10/79 vacating and striking the Court's order of 8/3/79 from the record; reinstating the Court's order of 7/6/79 granting in part and denying in part defendant's motion for protective order.
