Reference Bureau letter 62-112697-6 Re Bulet to Dallas 8/12/71 captioned "Committee to Investigate Assassinations, 927 15th Street Northwest Washington, D.C. 20005, Miscellaneous - Information Concerning".

On the afternoon of 4/3/72 an individual identifying himself as ROBERT P. SMITH of the aforementioned committee, telephonically requested an interview with SA ROBERT P. GEMBERLING, stating he desired to discuss various aspects of the assassination of President KENNEDY in an effort to resolve some questions that have arisen concerning same. Mr. SMITH was advised that due to the fact the information known to SA GEMBERLING was obtained through his official duties he would not be permitted to consent to such interview without appropriate authority.

Mr. SMITH subsequently was informed on the morning of 4/4/72 that Departmental Order #381-67 dated 6/29/67 prohibited discussion of captioned matter by SA GEMBERLING. Mr. SMITH was advised that should he desire, he could consult the Department of Justice concerning same.
