Referenced Bureau teletype pointed out that in
 connection with captioned civil action, the Bureau had entered
 into a stipulation to process, pursuant to FOIA, certain
 documents pertaining to the assassination of Dr. MARTIN
 LUTHER KING, JR., (Bureau code name - MURKIN) contained
 in the files of recipient divisions.

As a result, each recipient was to conduct a search
 of its indices for all main files identifiable with MURKIN
 and thereafter, Atlanta, along with several other offices
 was to forward one xerox copy each of all documents, including
 bulky exhibits and 1-As, which documents met certain criteria
 set forth by the Bureau.

Based on the above, Atlanta reviewed its indices and noted it had a main file on MURKIN, namely 44-2386, consisting of 23 volumes (2495 serials) and subfiles B (one volume), C (one volume), D (one volume), E (one volume), SF-1 (one volume), and SF-2 (one volume). In addition Atlanta had a racial matter case on the assassination of MARTIN LUTHER KING, JR., Racial Matter, Atlanta file 157-3094 which consisted of three volumes (266 serials).
