AFFIDAVIT OF WILLIAM N. PREUSSE

I, William N. Preusse, being duly sworn, depose and say as follows:

(1) I have been a Special Agent of the Federal Bureau of Investigation (FBI) for 26 1/2 years. During the past 20 1/2 years I have served at FBI Headquarters (FBIHQ) in a supervisory capacity in security-type investigations and I am currently assigned to the Document Classification Office at FBIHQ.

(2) I have been authorized to classify FBI documents pursuant to Executive Order (EO) 11652, Section 2(A)(3) and 2(C), and 28, C. F. R. 17.23, et seq. My current assignment in classification matters involves a variety of duties, mainly a review of classified documents requested by plaintiffs in civil actions directed against the FBI and/or current or past officials of this organization.

(3) (a) I have made a personal independent examination of all documents listed hereinafter and have personal knowledge of the information set forth in those documents for which the exemption (b)(1) pursuant to Title 5, United States Code, Section 552, is claimed.

(3) (b) The documents reviewed by me are in Appendix A and Appendix C to the "Report of the Department of Justice Task Force to Review the FBI Martin Luther King, Jr. Security and Assassination Investigations." My review encompassed 1 volume of Appendix A and 12 volumes of Appendix C. These documents contain summaries of documents some of the originals of which were deemed to have come under a court order in the cases styled Bernard S. Lee v. Clarence M. Kelley, et al. and Southern Christian Leadership Conference v. Clarence M. Kelley, et al., Civil Action Numbers 76-1185 and 76-1186, U. S. District Court for the District of Columbia. This court order is referred to in the affidavit of Mr. Michael E. Shaheen, Jr. to be filed with the court along with this affidavit. Some of the originals of these documents from which the summaries came were created at times when the FBI did not place a classification marking on documents prepared for internal use only, despite the fact the information contained therein would qualify for classification under EO 10450, the predecessor of EO 11652.

(3) (c) My examination was conducted in strict adherence to the standards and criteria found in EO 11652. Since each document contained a series of summaries of documents reviewed by the Task Force, my review was conducted on a paragraph by paragraph basis and classification designation made on the information contained in the paragraph. The classified paragraphs described below in this affidavit are exempt from automatic declassification as authorized by EO 11652.

(3) (d) The exemption Categories are described in Section 5(B) of the EO as follows:

(1) Foreign Agency - Material or information furnished in confidence by a foreign government or international organization.

(2) Sources and Methods - Material specifically covered by statute or pertaining to cryptography or disclosing intelligence sources or methods.

(3) Foreign Interest - Material disclosing a system, plan, installation, project or specific foreign relations matter, the continued protection of which is essential to national security.

(4) The pages listed below, which are attached to the affidavit of Mr. Michael E. Shaheen, Jr. to be filed with the Court along with this affidavit, come within the scope of the request. The pages specifically examined by the affiant in Appendix A and C are identified by numbers which appear circled in the bottom center portion of the pages. The circled numbers appear sequentially, but appear only on pages which contain classified information. The pages attached to the affidavit of Michael E. Shaheen, Jr. from Volumes 2, 3, 4 and 5 of Appendix C were divided for purposes of convenience into the pages which pertained to the assassination of Dr. Martin Luther King, Jr. (MURKIN) and the pages which pertained to the security-type investigation conducted of Dr. King (SECURITY). This affidavit utilizes the same division.
