  The following statement is made upon my personal knowledge and belief.
- Office of Professional Responsibility to work with the Martin Luther King, Jr. Task Force (Task Force) in its review of Department of Justice and Federal Bureau of Investigation files relative to Dr. King.
- 2. In connection with this assignment, I traveled to Memphis, Tennessee, on or about October 18, 1976, for the purpose of reviewing and securing copies of relevant Memphis Police Department (MPD) records which were in the custody of Hugh W. Stanton, Jr., District Attorney General for Shelby County, Tennessee.
- 3. District Attorney General Stanton was assured by me that the purpose of reviewing the records and securing copies of relevant documents was for the preparation of the Task Force's report on the assassination of Dr. King to the United States Attorney General.
