THE QUOTE TWENTY PHOTOGRAPHS OF POSSIBLE WHITE MALE AMERICANS UNQUOTE MENTIONED IN REBUCAB WERE NOT ENTERED IN MEXICO CITY FILE OF OSWALD INVESTIGATION AND THEIR DISPOSITION IS NOT EVIDENT FROM FILE.

THE COVER LETTER OF MEXICO CITY LHM, FEBRUARY TWO FOUR, ONE NINE SIX FOUR, WOULD INDICATE THE TWENTY PHOTOS IN

QUESTION WERE NOT FLOWN TO THE DALLAS OFFICE BY SA ELDON D. RUDD ON NOVEMBER TWO THREE, ONE NINE SIX THREE, WHEN HE CARRIED PHOTOS OF AN UNIDENTIFIED MALE

[REDACTED] OCTOBER ONE AND FOUR, ONE NINE SIX THREE, AS MENTIONED IN MEXICO CITY LETTER, APRIL SIX, ONE NINE SIX FOUR.

FURTHERMORE, THE MEXICO CITY LHM OF FEBRUARY TWO FOUR, ONE NINE SIX FOUR, INDICATES THESE TWENTY PHOTOS WERE NOT RECEIVED BY LEGAT, MEXICO FROM CIA [REDACTED] UNTIL FEBRUARY ONE NINE, ONE NINE SIX FOUR.

CIA [REDACTED] ADVISED ON SEPTEMBER EIGHTEEN INSTANT THAT THE TWENTY PHOTOGRAPHS ARE NOT AVAILABLE AT MEXICO CITY BUT MAY BE AVAILABLE AT WASHINGTON HEADQUARTERS.
