Internal indications reveal was of more than one single page

S21 4/9/65 <sup>unsuccessful</sup> An effort to turn this source over to the FBI is revealed. There has to have been some prelude, not provided some internal CIA deliberation of just a violation of its charter & the limitations it imposed & second, the decision to attempt to turn this self-important & politically important person/source over to the FBI.
