STATEMENT OF POINTS AND AUTHORITIES IN SUPPORT OF DEFENDANTS' MOTION FOR LEAVE TO AMEND THE RECORD

Defendants have moved to amend the record in this Freedom of Information Act litigation. Defendants originally moved for summary judgment on May 26, 1978. In support of its motion, defendant Central Intelligence Agency submitted the Affidavits of Robert W. Gambino and Robert E. Owen accompanying all documents that were released subject to deletion. For the convenience of the Court the defendants have now marked each document to indicate the exemption claimed.

The requested amendment of the record does not alter substantively, the position of the defendants or the bases for their original motion. Rather, this substitution is intended only to clarify the record describing the documents at issue in this litigation and eliminate duplication that would otherwise remain in the record as completed on this date.
