**Synopsis:**

Confidential informants verified that MICHAEL and RUTH PAINE resided RD #1, Malvern, Pa., at ARTHUR YOUNG's residence, Paoli, Pa., prior to 1959 when they moved to Irving, Texas. RUTH PAINE received some bulky mail apparently from Russia.

**DETAILS:** On December 17, 1963, PH T-1 advised SA THOMAS F. LEWIS that the ARTHUR M. YOUNGS, Swedesford Road, reside RD #1, Malvern (Paoli), Pa. He advised that during the winter months the YOUNG's reside at 1810 Delancey Place, Philadelphia.

PH T-2 advised on December 17, 1963, that he recalls the YOUNGS residing on Swedesford Road, Paoli, Pa., at least the past ten years. It is his recollection that from 1948 to October 1959 MICHAEL PAINE and his wife, RUTH PAINE, resided in an apartment which had formerly been a barn located on the YOUNG property. He stated the PAINES were not well known in the area and he did not recall whether or not they were employed locally or whether they had any friends or relatives in the area. He did not recall whether there was any blood relationship between the PAINES and the YOUNGS.

He said that on several occasions he recalled that he had seen mail in the PAINE mailbox which apparently came from Russia due to the postmarks and stamps on the mail. He recalled these letters came in large, brown, thick envelopes which gave

him the impression they contained magazines and/or newspapers. It was his recollection he noted these probable mailings from Russia on six or eight occasions while the PAINES resided on the YOUNG property.

PH T-2 said that on several occasions he had met RUTH HYDE PAINE and he described her as a tall woman in her mid-20's. He said he could not recall ever having seen MICHAEL PAINE.

He stated the PAINES had moved to 2515 West 5th Street, Irving, Texas, in October 1959.
