1. Is CIA item #509-803 identical with Warren Commission Document number 347?
If not, please specify any differences with as much detail as possible.
2. For purposes of this litigation, will defendants consider CIA item # 509-803 identical to Warren Commission Document number 347?
3. CIA item #498-204, a CIA cable dated January 29, 1964, refers to a "report on Lee Oswald's activities in Mexico" which was to be presented to the Warren Commission on February 1, 1964. Is the CIA report to the Warren Commission referred to above identical with CIA item #509-803?
4. If the answer to question number 3 is yes, please indicate whether the recipient of the cable referred to above (CIA item #509-803) was the CIA station in Mexico. Please also indicate whether the sender of this cable was either CIA Headquarters in Washington, D.C. or CIA Headquarters in Langley, Virginia.
5. Please specify in as much detail as possible all of your grounds for contending that CIA item #509-803 is exempt from the Freedom of Information Act as revised.
6. Does CIA item #509-803 specifically mention any CIA sources or methods not already mentioned in publicly available Warren Commission or CIA documents?
7. Does CIA item # 509-803 in fact specifically mention any CIA source or method?
8. Does CIA item #509-803 contain any information on Lee Harvey Oswald's activities in Mexico City which is not available in publicly released CIA or Warren Commission documents?

9. If the answer to question number 8 is yes, of the information on Lee Harvey Oswald's activities in Mexico found in CIA item #509-803, what percentage is publicly available in other CIA or Warren Commission documents?
10. Of all of the information contained in CIA item #509-803, what percentage is publicly available in other CIA or Warren Commission documents?
