Dear Mr. Fisher:

Enclosed are the required number of copies of the Docketing Statements in Nos. 86-5289 and 5290 and of both Entries of Appearance. I am sending copies to the Department of Justice along with a copy of this letter to explain my inability to specify at this time what I plan to use in the Appendix.

The case record contains complete statements of my surgeries and medical conditions and limitations prior to this past January 20, along with copies of medical bills reflecting the seriousness of the major arterial and venous circulatory disorders and other illnesses. On January 20 I had additional surgery that was followed by additional venous thrombosis. As a result I am even further limited in what I am able to do safely or at all. I am further limited in the use of stairs and I may not stand still even for brief periods. I spend three hours daily in walking therapy, alternately walking (at most about two city blocks at a time) and resting with my left leg elevated. As a result of the new thrombosis, I am also instructed to spend two hours a day lying flat on my back with my legs elevated. At all other times I must keep my legs elevated when I sit, including while typing. It thus is not possible for me to search and prepare the Appendix. However, I do not plan to use anything that I did not use pro se.

I do not know whether any transcript has been prepared of the single calendar call held by Judge Smith after I was pro se and much as I would like to use it and to be before the appeals court I cannot afford to pay for transcription and copies from my modest Social Security check, my only regular income.

I intend this letter to serve as my certification of service to Department counsel and to this court and as Appendix notification and hope that it will be.
