MEMORANDUM IN OPPOSITION TO PLAINTIFF'S MOTIONS TO COMPEL RELEASE OF (1) "WITHHELD" FBI LAB TICKLER MATERIALS AND OF (2) NEUTRON ACTIVATION AND SPECTROGRAPHIC MATERIALS

In motions filed on December 24 and December 29, 1980, plaintiff has requested this Court to compel the Department of Justice to release documents that are either not relevant to this case, not in existence, or already in plaintiff's possession. By filing these motions, plaintiff has once again ignored this Court's finding of February 26, 1980 "that [a] proper and good faith search has been made [by the FBI] for all items responsive to plaintiff's request."

In the motion to compel the release of "Withheld FBI Lab Tickler Materials," plaintiff requests the release of three documents that the FBI has stated have nothing to do with plaintiff's FOIA request or Martin Luther King in any manner whatsoever. According to the letter from the FBI attached to plaintiff's motion, the copies were merely misfiled in the tickler file of an individual FBI employee. The documents are available for in camera inspection to prove to the Court that they are not relevant to Mr. Weisberg's interests. However, since the FBI has categorically stated that the documents deal with matters of no concern to this case, such a review should be unnecessary,

Plaintiff's second motion requests this Court to compel the release of "neutron activation and spectrographic materials" to Mr. Weisberg. This matter was discussed exhaustively in the deposition of FBI Special Agent John Kilty on October 12, 1979. On pages 20 through 25 of that deposition, Mr. Kilty was asked about both neutron activation and spectrographic materials. to neutron activation documents, he testified that these documents had already been provided to Mr. Weisberg (p. 22, 23), a recollection that is supported by a receipt for these documents signed by Harold Weisberg on March 23, 1976 (see Attachment A, item 8). The spectrographic plates, which are apparently the "spectrographic materials" referred to in his motion, do not exist, as indicated by a recent letter to Mr. Weisberg from the FBI (Attachment B). Although these plates have never been considered by the FBI to be part of plaintiff's Freedom of Information Act requests, they have been recently searched for to honor an informal promise by a Department of Justice employee to give copies of any plates that might be located to Mr. Weisberg. This search, as stated in Attachment B, has not resulted in the locating of any spectrographic plates.

Mr. Weisberg's most recent motions serve to demonstrate once again the propriety of this Court's 10-month-old order regarding "scope of search." These motions also fail to provide any basis for denial of defendant's pending motion for summary judgment.


