Enclosed for the Bureau are four copies of a  
letterhead memorandum reflecting an interview with ROBERT  
MAHEU by SA [redacted] on 4/18/61. Enclosed for CG, LA,  
and MM is one copy each of this memorandum. Enclosed for LV  
are three copies of this memorandum, one of which is designated  
for the USA Reno. U

MAHEU did not say that he was working with CIA but  
from his statements this insinuation was made. MAHEU stated  
that the facts could be verified by contacting [redacted] CIA, and that an  
analysis of his telephone calls, which he indicates had  
been checked by the FBI, could be ascertained that he had made  
numerous calls to Executive 3-6115 (telephone number for CIA).  
MAHEU stated that he was quite disturbed by instant investigation  
indicating that it could possibly have jeopardized the work that
