Bureau is disseminating carefully paraphrased version
of information set forth in reairtel to CIA, State, Department
and military intelligence agencies, [redacted]

New York and Chicago should closely follow this matter
and should immediately advise Bureau if any additional data is
received regarding alleged plot against Castro. In particular,
if information should be received indicating that Giancana plans
travel to Miami area or other trips which could be to contact
individuals implicated in alleged plot, Bureau and interested
offices should be expeditiously advised and recommendations should
be furnished concerning close coverage of Giancana with view to
identifying any contacts he might make regarding this matter,
including physical surveillance. Chicago should promptly advise
if it has received any information indicating recent travel on
Giancana's part to Miami or other areas, such as Mexico, which might
indicate possible contacts with anti-Castro elements. Chicago
should also review appropriate records to determine if Giancana
has recently made any long-distance phone calls to persons who
be involved in the alleged plot against Castro.

Miami should immediately furnish its comments regarding
the identity of person who allegedly met with Giancana at
