DECLARATION OF LEE S. STRICKLAND

LEE S. STRICKLAND hereby declares and says:

- 1. I presently serve as an Assistant General Counsel and senior trial attorney for the United States Central Intelligence Agency ("CIA" or "Agency") having joined the CIA Office of General Counsel in 1975. I am admitted to practice before the bars of the State of Virginia and the District of Columbia. I make the following statements pursuant to my personal knowledge.
- 2. Upon receipt of this Court's Memorandum Opinion and Order of 30 July 1984, I requested that my staff retrieve a copy of Document No. 1648-452-C and all justifications which had been submitted in support of the withholding. The review

of this material by my Office and the Department of Justice indicated that Mr. Dube in his Affidavit of 22 July 1982 had determined that exemptions (b)(1), (b)(3), and (b)(5) applied coextensively to the document in its entirety. At my personal request, Mr. Dube again reviewed the document and reaffirmed his initial determination. This Court was so advised by the filing of the government's Motion for Clarification.

3. Soon thereafter, I was advised by staff, who had been involved in the effort described above, that document 1648-452-C had been at issue in an earlier FOIA civil action, Borosage v. Central Intelligence Agency, Civil Action No. 75-0944 (D.D.C.). In that litigation, the plaintiff had sought, inter alia, documents which this Agency had provided to the President's Commission To Investigate Domestic C.I.A. Activities ("Rockefeller Commission"). In presenting and justifying the Agency's denial of these documents, the affidavits of Mr. E. H. Knoche, then Associate Deputy to the Director of Central Intelligence for the Intelligence Community, and Ms. Eloise Page, then Chief of the Operations Staff of the Directorate of Operations, executed on 24 October 1975, were filed with the trial court. A copy of each of these affidavits are submitted herewith and marked as Exhibit A and B, respectively. These affidavits detailed that the most senior officers of the Agency had reviewed this particular document as well as other related documents and had

determined that release would disclose details of covert intelligence activities as well as intelligence sources and methods within the scope of and protected by 50 U.S.C. \$403(d)(3). For these reasons, document 1648-452-C was denied in its entirety.

- 4. Subsequent to the filing of the affidavits referenced in paragraph 3, supra, extensive discussions were held between senior officials of this Agency and the Church Committee staff concerning the public disclosure of documents and/or information contained therein which were relevant to the Committee's inquiry. In light of the legislative disclosures which were made without the full concurrence of this Agency, Ms. Page, with the concurrence of the Director of Central Intelligence, determined that as a matter of policy, and to facilitate settlement of the litigation, certain portions of certain documents provided to the Committee would be released to the plaintiff.
- 5. In furtherance of the policy decision rendered by Ms. Eloise Page, certain redacted documents were produced on 7 May 1976 to plaintiff's counsel in the <u>Borosage</u> litigation. That release included the document identified as "2" in the <u>Borosage</u> litigation and "1648-452-C" in the instant law suit. A copy of that document as redacted and released in <u>Borosage</u> may be found as Exhibit A in the Declaration of Louis J. Dube, filed herewith.

AFFIDAVIT

Eloise Page being first duly sworn upon her oath, deposes and says:

- 1. I am Chief, Operations Staff of the Directorate for Operations of the Central Intelligence Agency. I have personal knowledge of the facts set forth herein, which facts were obtained by me in my official capacity.
- 2. Each of the documents described in the affidavit of E. H. Knoche includes some discussion or mention of plans for covert action operations involving foreign leaders. Some of these documents include descriptions of the proposed methods contemplated, the operatives to be employed and techniques proposed. Others include accounts of activities of foreign groups that considered plans of a similar nature and describe covert relationships that existed between CIA and these groups.

The nations involved would, in the face of such official acknowledgement, be obliged to take some action which they would otherwise not have contemplated. Such action, at the very least, would result in diplomatic protest and could result in stronger measures.

4. Although there have been widely circulated reports in the media concerning such covert operations, there has been to date no official confirmation of the details of the plans nor the countries or personalities involved.

The disclosure of their involvement would at the very least impair their continued ability to provide foreign intelligence and might, in some instances, place their lives and those of their families in immediate jeopardy.

6. Additionally many of these documents include detailed discussions concerning intelligence methods the revelation of which would likely result in the compromise of these methods to the detriment of the U.S. Government's ability to collect foreign intelligence.
