We've been iced in, it has been very cold and to keep the place warm enough I've had the door to my office clsed until this minutes. And with an electric heater going it remains cold. With regard to the rifle and asmo, the importance was not curiosity that could be satisfied by a different catalogue but what pertained almost a decade earlier to the model of rifle and asmo then current. This again is particularly true with rogard to the sighting of the rifle. It also re; ates to the characteristics and behavior of the ammo and again to the FBI's knowledge, not reflected in the records disclosed. Also not reflected with regard to the scope. (REMENT Redfield.)

All in all, we made out OK. The windchills down to 50 below here knocked me out when I did no more than go to the mailbox. The protine was went crazy again, I got into the hemorrhaging range again but had only a slight one, and it is now down but shifting.
