COMPLAINT

For Declaratory and Injunctive Relief

- 1. This case is brought under the Administrative Procedure Act, 5 U.S.C. 301 and 701-706, as amended; Department of Justice Order No. 528-73, 38 F.R. 19029, July 17, 1973, 28 C.F.R. 50.8 (see attached as Exhibit 1); the Freedom of Information Act, 5 U.S.C. 552; and under 28 U.S.C. 1331.
- 2. This Court has jurisdiction over this cause of action pursuant to 5 U.S.C. 701-706; 5 U.S.C. 552(a)(4)(B); and 28 U.S.C. 1331.

- 3. Plaintiff Bernard Fensterwald, Jr., is an individual residing at 811 Prince Street, Alexandria, Virginia 22314, and he is also Executive Director of the private, non-profit Committee to Investigate Assassinations (with offices at Suite 900, 1000 Wilson Boulevard, Arlington, Virginia 22209).
- 4. Defendant William French Smith is the Attorney General of the United States. Defendant Department of Justice is the agency of the United States over which the Attorney General presides, and it has the possession of the records to which plaintiff seeks access as an historical researcher.

FACTS

5. On July 17, 1973, the Attorney General issued Order No. 528-73. The order states in part:

In response to the increased demand for access to investigatory files of historical interest that were compiled by the Department of Justice for law enforcement purposes and are thus exempted from compulsory disclosure under the Freedom of Information Act, the Department has decided to modify to the extent hereinafter indicated its general practice regarding their discretionary release.

Persons outside the Executive Branch engaged in historical research projects will be accorded access to information or material of historical interest contained within this Department's investigatory files compiled for law enforcement purposes that are more than fifteen years old and are no longer substantially related to current investigative or law enforcement activities, subject to deletions to the minimum extent deemed necessary to protect law enforcement efficiency and the privacy, confidences, or other legitimate interests of any person named or identified in such files. (See Exhibit 1 hereto)

- 6. On March 29, 1983, plaintiff made a formal application as a serious researcher into the circumstances surrounding the several major assassinations of the 1960s. (See Exhibit 2 hereto)
- 7. In the application, plaintiff stated, as evidence of his seriousness as an historical researcher, that he had published a book on the assassination of President Kennedy.
- 8. The application indicated that plaintiff was Executive Director of the Committee to Investigate Assassinations.
- 9. Attached to the application was a <u>curriculum vitae</u> of plaintiff. (<u>See</u> Exhibit 3 hereto) It was indicated that he had had several high security clearances, beginning in 1942.
- 10. Having received no reply and no acknowledgment to his March 29, 1983 request, plaintiff sent a follow-up letter on June 14, 1983. (See Exhibit 4 hereto)
- 11. This follow-up appears to have sparked a form letter which was a nonresponse from the Department of Justice on June 22, 1983. The application under
 28 C.F.R. 50.8 was treated as a routine request for information under the
 Freedom of Information Act and not as an application for access to records as
 an historical researcher. (See Exhibit 5 hereto)
- 12. Since June 22, 1983, nothing further has been forthcoming from defendants.
- 13. Plaintiff has exhausted his administrative remedies, having written twice to the Attorney General without substantive reply.

LEGAL WRONG

- 14. Continuing delay by an Agency to the taking of final agency action, in violation of the requirement that every agency proceed with reasonable speed, constitutes a legal wrong within the meaning of 5 U.S.C. 702.
- 15. Plaintiff is aggrieved by the denial of his application because of the impediment which it poses to the continuation of his historical research of the deaths into the circumstances/of President John F. Kennedy, Senator Robert F. Kennedy, and Dr. Martin Luther King. Without access as an historical researcher, plaintiff must rely exclusively on the Freedom of Information Act, which is both costly and time consuming. Further, the exemptions under the Freedom of Information Act have been applied to assassination records in such a way as to make large blocks of material unavailable under the Freedom of Information Act.

RELIEF REQUESTED

The Court is requested to declare that defendants are acting arbitrarily and capriciously by denying plaintiff's application, and, further, order that such application be promptly granted.

- \$ 50.8 Policy with regard to criteria for discretionary access to investigatory records of historical interest.
- (a) In response to the increased demand for access to investigatory files of historical interest that were compiled by the Department of Justice for law enforcement purposes and are thus exempted from compulsory disclosure under the Freedom of Information Act, the Department has decided to modify to the extent hereinafter indicated its general practice regarding their discretionary release. Issuance of this section and actions considered or taken pursuant hereto are not to be deemed a waiver of the Government's position that the materials in question are exempted under the Act. By providing for exemptions in the Act, Congress conferred upon agencies the option, at the discretion of the agency, to grant or deny access to exempt materials unless prohibited by other law. Possible releases that may be considered under this section are at the sole discretion of the Attorney General and of those persons to whom authority hereunder may be
- (b) Persons outside the Executive Branch engaged in historical research projects will be accorded access to information or material of historical interest contained within this Department's investigatory files compiled for law enforcement purposes that are more than fifteen years old and are no longer substantially related to current investigative or law enforcement activities, subject to deletions to the minimum extent deemed necessary to protect law enforcement efficiency and the privacy, confidences, or other legitimate interests of any person named or identified in such files.

Access may be requested pursuant to the Department's regulations in 28 CFR Part 16, Subpart A, as revised February 14, 1973, which set forth procedures and fees for processing such requests.

(c) The deletions referred to above will generally be as follows:

(1) Names or other identifying information as to informants:

- (2) Names or other identifying information as to law enforcement personnel, where the disclosure of such information would jeopardize the safety of the employee or his family, or would disclose information about an employee's assignments that would impair his ability to work effectively;
- (3) Unsubstantiated charges, defamatory material, matter involving an unwarranted invasion of privacy, or other matter which may be used adversely to affect private persons:

(4) Investigatory techniques and procedures; and

(5) Information the release of which would deprive an individual of a right to a fair trial or impartial adjudication, or would interfere with law enforcement functions designed directly to protect individuals against violations of law.

(d) This policy for the exercise of administrative discretion is designed to further the public's knowledge of matters of historical interest and, at the same time, to preserve this Department's law enforcement efficiency and protect the legitimate interests of private persons.

§ 50.9 Policy with regard to open judicial proceedings.

Because of the vital public interest in open judicial proceedings, the Government has a general overriding affirmative duty to oppose their closure. There is, moreover, a strong presumption against closing proceedings or portions thereof, and the Department of Justice foresees very few cases in which closure would be warranted. The Government should take a position on any motion to close a judicial proceeding, and should ordinarily oppose closure; it should move for or

From 1950-1956, I was an employee of the Department of State, with appropriate security clearances. From 1957 to 1969, I was an employee of the U.S. Senate and held clearances during this period.

To indicate my seriousness as a researcher into assassinations, it might be noted that I have published several articles and one book on the subject, Coincidence or Conspiracy?, Zebra Books (N.Y.), 1977. Currently, I am Executive Director of the private Committee to Investigate Assassinations.

Would you be kind enough to inform me of what I must do to qualify for access as a historical researcher.

It is also responsible for the conduct of certain civil litigation, particularly that involving prison and parole matters, and civil litigation involving electronic surveillance.

This information is stored in files which are indexed in central classification systems under the names of the individuals or entities who are parties to the litigation. In addition, there is some information maintained by the Tax Division which relates to various procedures and guidelines relevant to the processing of tax cases, as well as files on its administrative functions.

In 18 pilot districts, the 10 United States Trustees are responsible for the effective administration of bankruptcy cases arising under Chapters 7, 11 and 13 of the Bankruptcy Code (11 U.S.C.). Responsibilities include monitoring and supervising private (panel) trustees and debtors—in—possession to ensure that the interests of all parties are protected. The offices of United States Trustees and three of the offices of Assistant United States Trustees maintain duplicate copies of certain court pleadings and material relating to specific cases or entities. Case files are not centralized in Washington, D.C. Created by the Civil Rights Act of 1964, it is the only agency to which Congress has assigned the task of providing direct help to communities in the resolution of "disputes, disagreements or difficulties relating to discriminatory practices based on race, color or national origin . . . " CRS helps communities at the request of State or local officials, or local citizens and organizations, and may also assist on its own motion when it suspects that peaceful relations among citizens are threatened. CRS maintains case files by city, state, and CRS case number. The CRS system of records under the Privacy Act contains the names of CRS employees, their case assignments, and the time allocated to each assignment. In addition, information reflecting the current status and handling of the cases is included in the system.
