INVESTIGATIVE HEMORANDUM

I reportedly stated to that his cousin was not specific about the nature of the job, but that it was worth some \$20,000 and involved shooting.



The cousin was also reportedly obsessed with the subject of "professional assessination". Conversation with his cousin allegedly took place prior to the assassination of Reverend Martin Luther KHIG. On reminding of his previous comments, he registered concern and stated that his cousin owned a rifle, and a white Ford Mustang fitting the description of the vehicle persued following Reverend KING's murder.

- Ih. On Saturday, 6 April 1968, Special Agent "Cy" BUSH, FBI, advised the undersigned that the FBI would undertake further interview of relative to the above matter. In view of the foregoing no additional action or referral is anticipated by this office.
