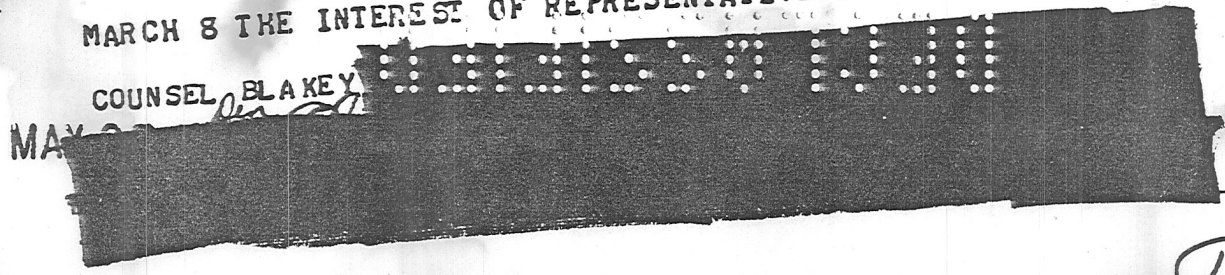

[REDACTED] THE ATTORNEY GENERAL SAID THAT HE PERSONALLY WOULD DEAL WITH THE QUESTION OF HIS SECRETARIAT'S COOPERATION, INCLUDING CONTACTING THE MEXICAN CITIZENS WHOM THE HOUSE SELECT COMMITTEE GROUP WOULD WISH TO INTERVIEW. HE ASKED THAT I SEND HIM THE NAMES OF THESE PERSONS, TOGETHER WITH AS MUCH INFORMATION AS POSSIBLE ON WHAT OTHER LINES THE COMMITTEE REPRESENTATIVES WOULD WISH TO PURSUE, IN ADVANCE OF THE ARRIVAL OF THE INVESTIGATORS, POINTING OUT THAT THIS COURSE COULD SAVE THE CODEL REPRESENTATIVES VALUABLE TIME.

2. AS SOON AS THE COMMITTEE STAFF CAN PROVIDE THIS INFORMATION, I WILL SEND IT TO THE ATTORNEY GENERAL, WHO I EXPECT WILL FOLLOW HIS USUAL PRACTICE OF PROMPT AND LIMITED OFFICIAL USE
